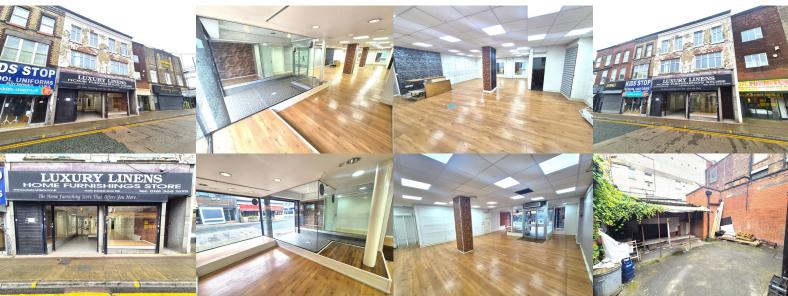
## Location

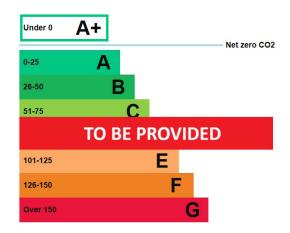
