LOCATION

Woking is a popular commuter town within Surrey with a population of 103,900 (2011 census). Surrounding towns including Guildford approximately 6 miles to the south-west and Reading approximately 20 miles to the north-west.

DESCRIPTION

The property occupies a central trading position on Commercial Way with a highly visible return frontage. The property forms part of the Wolsey Place Shopping Centre and is situated close to the Mercia Walk entrance.
