There is also the added benefit of a modern kitchen. WC facilities are located on the ground floor of the premises and the suite has 7 dedicated car parking spaces.

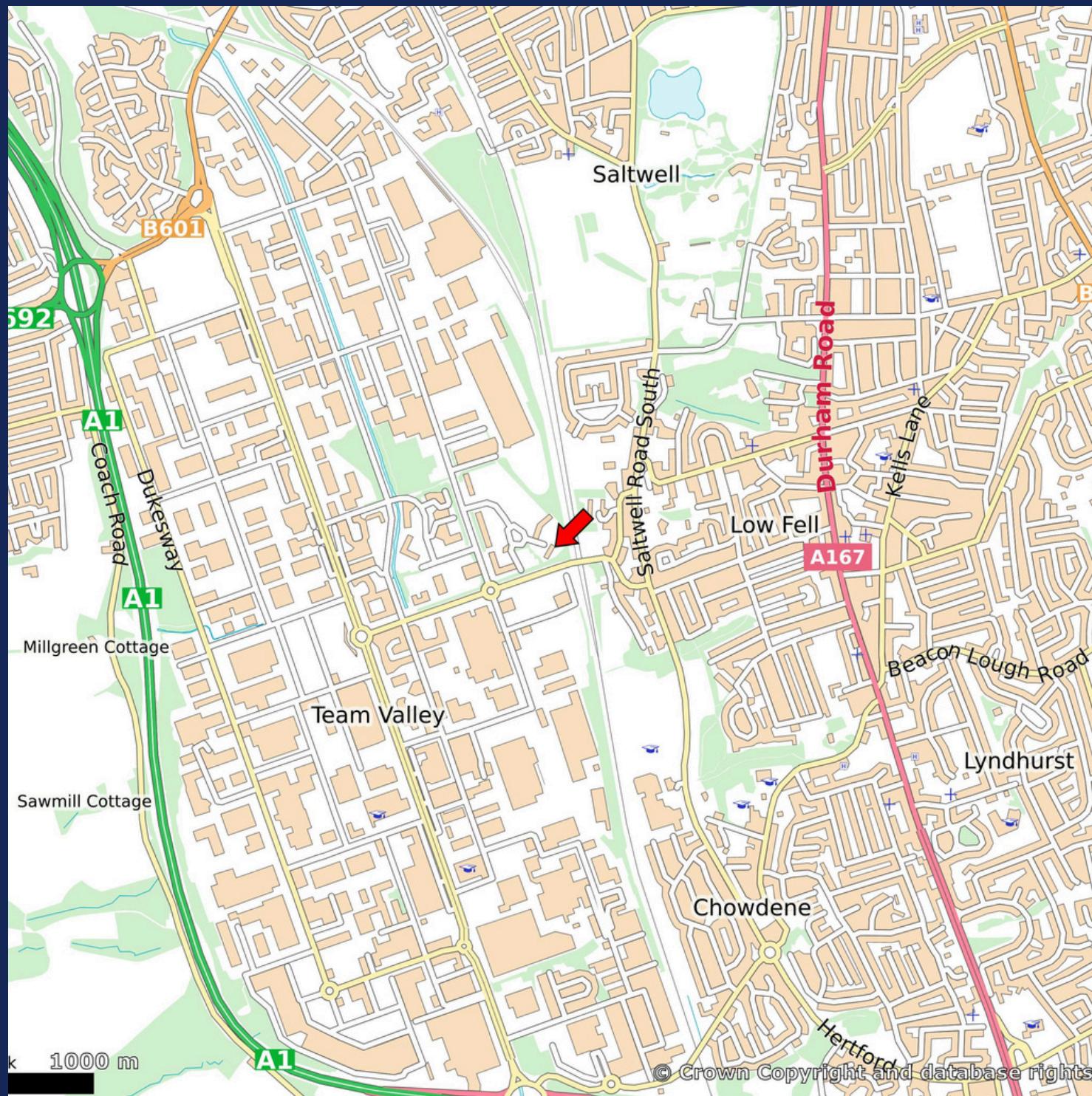
