LOCATION

Lombard House is prominently located on Old Hall Street, the ring road junction of Potteries Way (A50) and Bucknall New Road. Potteries Way (A50) is one of the main arterial routes around City Centre. This gives easy access to the A500 and Junctions 15 and 16 of the M6 Motorway.

Lombard House is located within Hanley City Centre as one of the main retail areas within the 5 towns of Stoke on Trent. The Potteries Shopping Centre which accommodates a wide range of amenities is located within 0.3 miles.

DESCRIPTION

The property comprises a substantial mid-terraced office building arranged over ground, first and second floor. The property is of brick and framework construction beneath a flat roof structure with a parapet wall around its perimeter.

Internally, the property comprises a combination of open plan and cellular accommodation over each floor although the absence of structural columns and walls allows for flexible configuration.

The property benefits from the following:

- Suspended ceilings with inset lighting
- Gas central heating and air conditioning (not tested)
- Perimeter trunking
- Parking to the rear for approximately 6 vehicles




