The Property is located within Balby, circa 1 mile south of Doncaster City Centre. Balby Carr Bank is located to the south of the Property, which connects to the A6182 (White Rose Way) to the east, with J3 of the M18 circa 2 miles to the southeast of the Property.


The Property is circa 3.5 miles from iPort, a multimodal logistics hub, which provides rail access to the national network and all the countries deep sea ports within 7 hours. The Property is also under an hour from east coast ports, including Hull, Grimsby and Immingham, which offer access to European markets.

The area surrounding the Property includes existing housing to the west, the A630 to the north and the East Coast Mainline railway to the east. To the south of the Property there is a mix of commercial / employment uses along Balby Carr Bank, including Total Park (a new industrial / logistics development of 5 units totalling circa 376,419 sq. ft.).

Occupiers in the area surrounding the Property include Bekaert / Bridon, Commercial Vehicle Auctions, Montracon, Amazon, Hitachi Rail, Wincanton, Morrisons and B&Q.

Doncaster Train Station is located circa 1 mile north of the Property, offering direct connections to towns and cities across the United Kingdom, including London, Manchester, Birmingham, Leeds and Edinburgh.

The buildings extend to circa 39,000 sq m (420,000 sq ft) in total (source Valuation Office Agency) and comprises offices, manufacturing and warehouse buildings. Floor plans of the buildings, asbestos reports and a report on the chimney are available in the data room.

There is hardstanding to the north of the building, which is has been used for car parking, as well as to the east and south of the Property, which has been used for vehicle loading and circulation, as well as storage.

The main vehicular access to the Property is from St Catherine's Avenue to the North, with further accesses from Balby Carr Bank to the West. Property is from Wilton Street to the northeast and there is also a closed gated access from Pepper Mill Lane to the north.

Development Considerations

The Statutory Development Plan for Doncaster comprises the Doncaster Local Plan (2015-2035) adopted on 23rd September 2021.

The Plan identifies the Property within the Middle Bank Employment Policy Area (Policy 4) and also within the Doncaster Main Urban Area Development Limits (Policy 1).

The area to the west of the Property is allocated as a 'Residential Policy Area', with the railway line to the east allocated as one of the 'Main Transport Corridors' (see Doncaster Local Plan Proposal Map Extract below).

Policy 4 seeks to retain land and premises within an 'Employment Policy Area' in employment uses. However, given the location of the Property immediately adjacent to a 'Residential Policy Area', there may be potential for residential redevelopment, subject to securing the relevant consents.

In addition, we understand the existing chimney within the Property is a locally listed heritage asset included on the Doncaster heritage register in 2021 under reference DLHL20.

A Pre Application enquiry was submitted to Doncaster Council in September 2025 accompanied by 3 Proposed Sketch Plans. These plans propose the following:

- Residential development of 204 dwellings (Option 1);
- Commercial / Industrial development of circa 218,750 sq. ft. and residential development of 32 dwellings (Option 2); and
- Commercial / Industrial development of circa 251,700 sq. ft. (Option 3).



Title

There are various rights and restrictions that relate to the Property, including a lease to NORTHERN POWERGRID (YORKSHIRE) PLC relating to the Electrical Sub Station.

There is an electrical Sub Station within the Property, to the north of the main vehicular access to the Property from St Catherine's Avenue.
