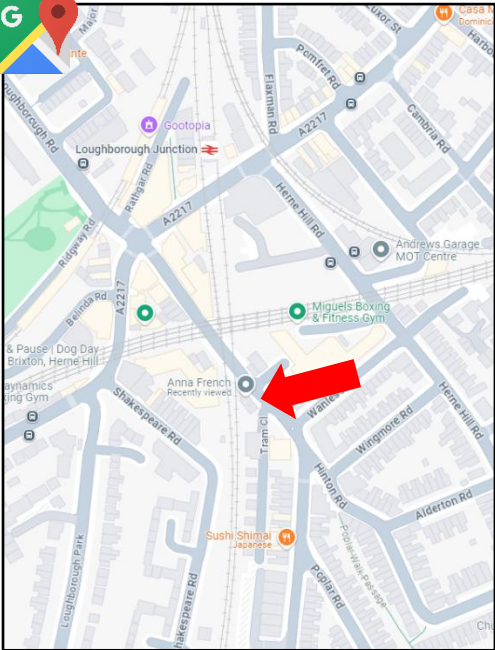

Description

A fully refurbished series of arches connected via a steel framed unit either side. The space benefits from a secure private yard on the Hinton Road side and a shared yard space on the Shakespeare Road side. Both sides are accessed via shutter doors with multiple pedestrian entrances directly onto Hinton Road.

Internally the space benefits from:

- 3-Phase power
- Strip lighting
- Electric roller shutter & Concertina shutter with a separate pedestrian entrance
- Water & Waste
- WC facilities

Location

The arches are located on Hinton Road which is within walking distance of Brixton Underground & Railway Station as well as Loughborough Junction Railway Station being a 3-minute walk away. Loughborough Junction Station is well served by Thameslink & Southeastern services into Central London. Hinton Road is located just off Coldharbour Lane (A2217) next to the Tesco Express. Coldharbour Lane connects with Brixton Road providing access to Central London (north) and Streatham (south). There are good bus links connecting the local area.
