## Location

The property occupies an established and prominent retail location on the popular Castle Street in the town centre of Ludlow, situated amongst a range of national and independent traders including SPAR, White Stuff, Vision Express. The property is also within a short walking distance of the Ludlow train station and public car parks.

The property fronts the main Ludlow square which hosts markets four times a week, and is just 150m away from the iconic Ludlow Castle.

Ludlow is an attractive historic south Shropshire Market Town and tourist centre serving a wide catchment area located approximately 30 miles south of Shrewsbury and 24 miles north of Hereford with access via the A49 trunk road.

## Description

The property comprises a well-appointed ground floor retail premises with basement storage extending in total to approx. 1,511 sqft (140.4 sqm) and forming part of this attractive Grade II listed property. The property benefits from large amounts of natural light having an attractive glazed display frontage with recessed entranceway.

The property lends itself suitable for a variety of uses, subject to planning and is available for immediate occupation.

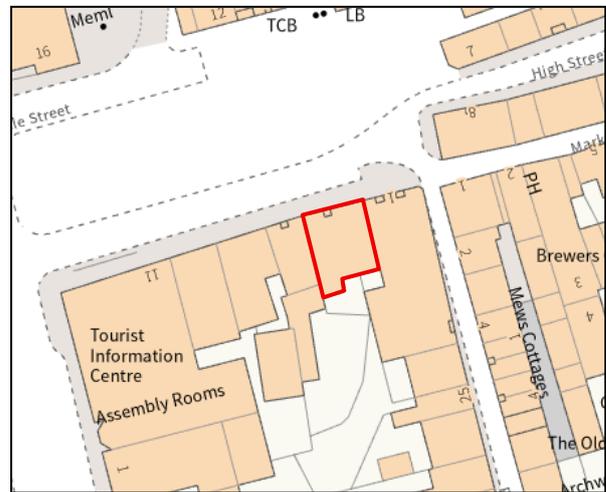
