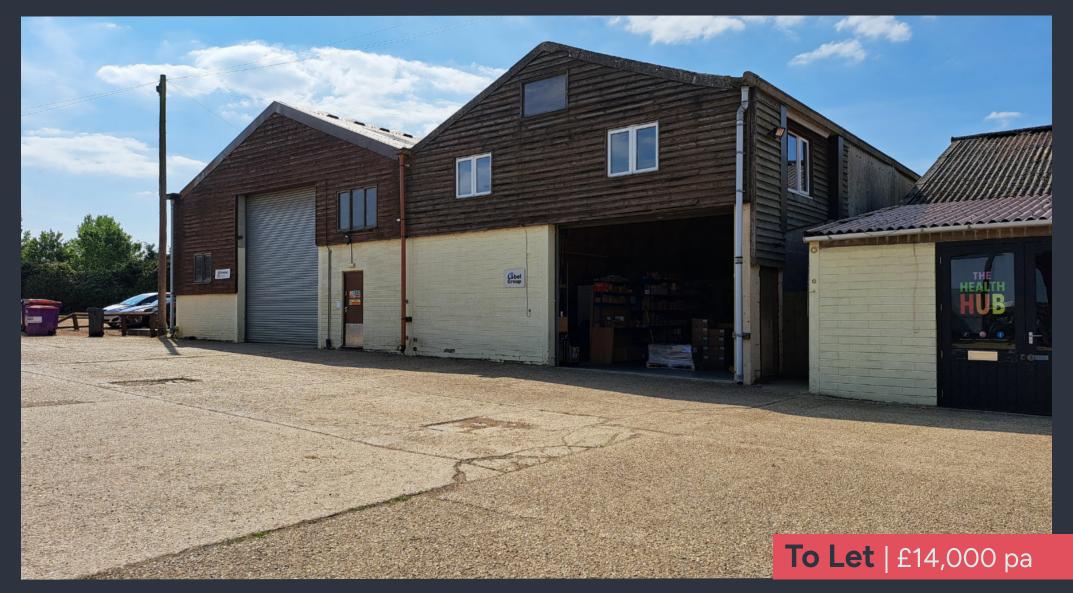

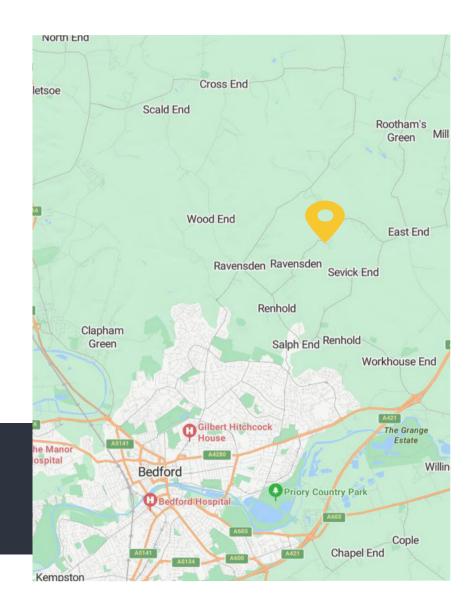
Located between the picturesque village of Ravensden and Wilden.

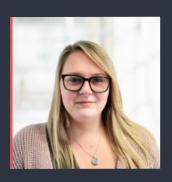
