## Location

Benford Court is an established courtyard-style development of modern business units, prominently situated just off Lower Cape on Cape Road, approximately 1 mile south of Warwick town centre.

The property benefits from excellent road connectivity, being a short drive from the A46 Warwick Bypass via the Birmingham Road junction. The A46 provides swift onward access to Junction 15 of the M40 motorway, offering direct links to Birmingham, Oxford, London and the wider Midlands motorway network. This strategic positioning makes Benford Court particularly well suited to businesses requiring efficient regional and national distribution.

Warwick is well served by rail connections, with Warwick and Warwick Parkway railway stations both within easy reach, providing regular services to Birmingham, Leamington Spa and London Marylebone. The location is also close to major employment centers within Warwick, Leamington Spa and the wider Coventry and Warwickshire sub-region, an area recognised for its strong commercial base spanning professional services, manufacturing, technology and automotive sectors.







## Description

Constructed in late 2007, Benford Court comprises a total of six self-contained business units arranged in two terraces around an attractive central courtyard. Each unit provides a practical combination of storage or light industrial accommodation with high-quality office space, making the development suitable for a wide range of occupiers including SMEs, trade counter users and service-based businesses.

In further detail, the unit comprises:-

- Ground floor storage / workshop:
  - Floor to ceiling height of 3 metres.
  - Workshop accessed via a sectional up and over loading door.
  - Fluorescent lighting.
  - Painted concrete floor
  - DDA WC. & Lift Access
- First floor office accommodation:
  - Suspended ceiling incorp. LG3 Lighting
  - Aluminium framed double glazed windows
  - Neutral decoration
  - Carpet tile floor coverings
  - Low level perimeter trunking.
  - Electric radiators
  - Kitchen/tea point
  - WC.
- Externally, there is a small loading bay and allocated parking for 5 cars.
