Location

The Steel Centre is prominently located on Wainwright Road, on the established Shire Business Park, close to its junction with Brindley Road, approximately ½ mile from Junction 6 of the M5 motorway. The location therefore offers excellent access to the national motorway network.

The surrounding area comprises a mixture of industrial and office buildings, with notable nearby occupiers including Sytner BMW, Mazak, Evri and Worcester Bosch.

Description

The property comprises an industrial estate arranged to provide seven units on a self contained, 2.72 acre site.

All units are of steel portal frame construction with profile steel panel roofs. Unit 1 provides an open plan warehouse/workshop incorporating 7 tonne craneage, translucent roof panels, a manual roller shutter door and a mezzanine floor extending to approximately 323 sq ft.

Unit 1A includes two manual roller shutter doors and an eaves height of 3.75m.

Units 2 and 3 are currently interconnected but could be separated if required. Unit 2 includes 10 tonne and 5 tonne craneage, two electric roller shutter doors, a 6.2m eaves height and two storey office accommodation.


Unit 3 provides 3 tonne craneage, a concertina and dock level door and two storey office accommodation.

Unit 4 benefits from a 7m eaves height, an electric roller shutter door and LED lighting. A loading canopy spans Units 3 and 4, extending to approximately 4,228 sq ft.

Units 5 and 6 each benefit from manual roller shutter doors, LED lighting and translucent roof panels.

Externally, the estate offers a substantial hardstanding area providing car parking and a loading yard.
