## Description

The property comprises a mid-terrace commercial retail unit arranged over ground floor level with paid parking to the front of the unit, providing flexible accommodation suitable for a variety of uses, subject to obtaining the necessary planning consent.

The subject property provides a retail sales area with glazed frontage and electric roller shutter doors with space suitable for storage or office accommodation and WC facilities to the rear.

# Location

The subject property is well positioned on Lister Street, close to the busy York Road, offering excellent visibility and access to local amenities. The property is located in the centre of Hartlepool.

Hartlepool is a large coastal town in the north east of England lying approximately 14 miles north of Middlesbrough, 23 miles south of Sunderland and 30 miles south of Newcastle upon Tyne. The surrounding area includes various local businesses and services such as Razzle Dazzle, The Glass Shop, Eston Fish Bar and Tattoo along with numerous other local operators.

The area is well connected being adjacent to the A689 providing access to the A19 and via public transport with Hartlepool Train Station approximately 1 mile away. The property is situated in a bustling area of Hartlepool, which is a mixture of commercial and residential and benefits from excellent passing trade on a consistent basis.

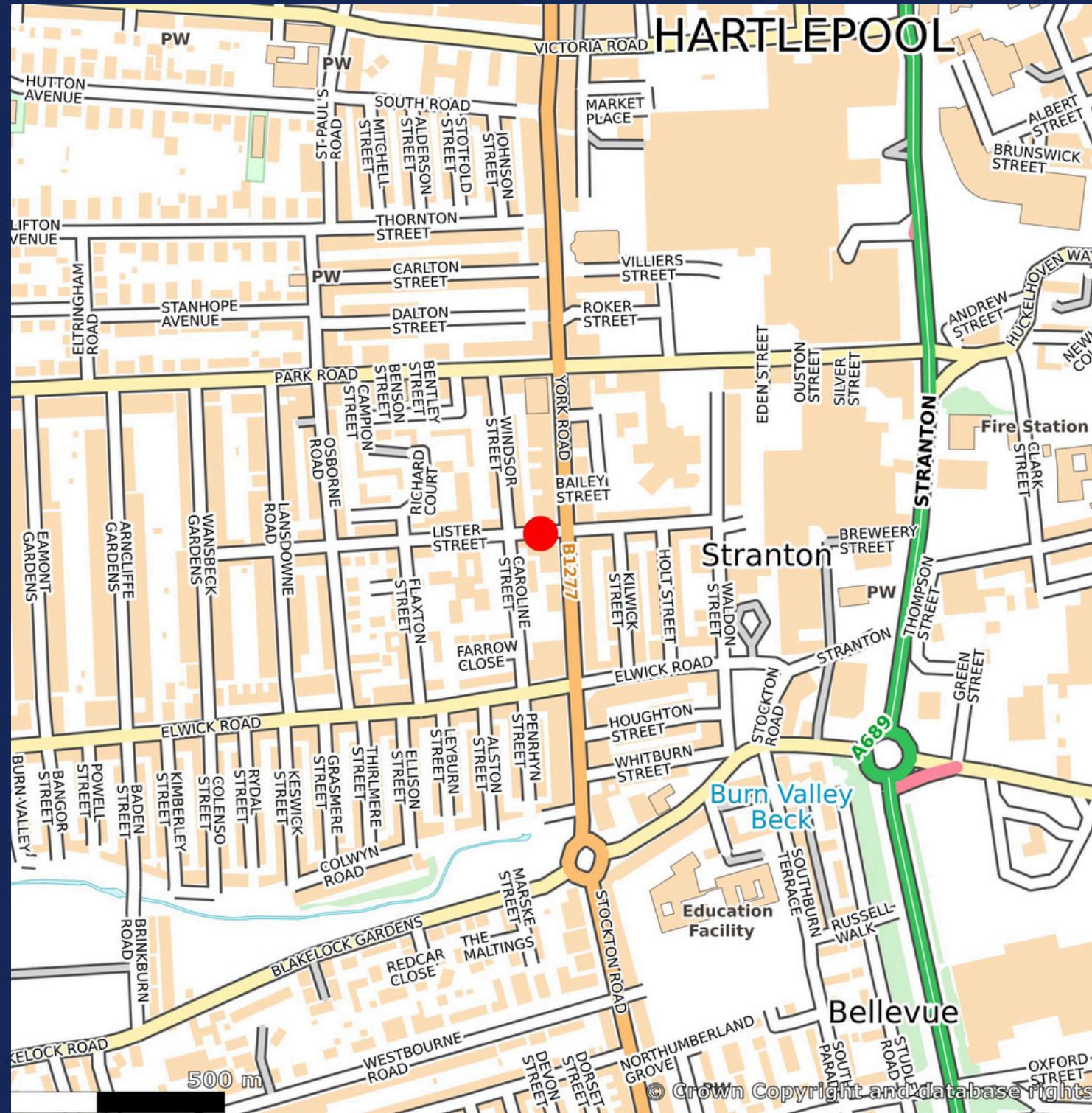
## Use / Planning
