LOCATION

Gloucester Business Park is located almost midway between Gloucester and Cheltenham, with its own link road to Junction 11A of the M5 motorway. It is approximately 4 miles from Gloucester, 6 miles from Cheltenham and adjoins the A417 dual carriageway trunk road to Swindon, M4 Motorway being approximately 30 miles away. The subject property is situated in Regent Court, in the business sector at the west of the park.

DESCRIPTION

The property comprises a modern semi-detached office buildings of brick construction under a traditional pitched roof with tile covering. The available suite is situated on the first floor and has been finished to a high specification including:

- Fully raised accessed floors
- Air conditioning
- Lift access
- Suspended ceilings with LG3 compliant lighting
- Gas fired central heating
- Metal framed double glazed windows
- Male, female and disabled WC facilities

The property is set within an attractive landscaped area and benefits from allocated parking.
