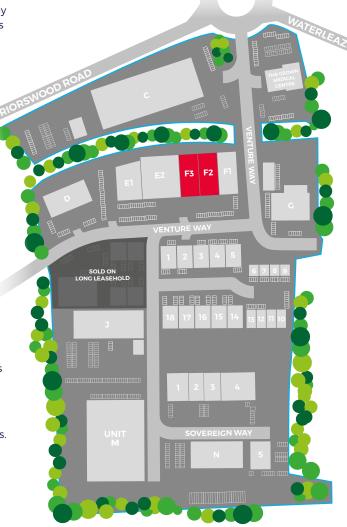

#### **DESCRIPTION**

The properties comprise two adjoining steel portal frame units under a double skin roof. The warehouse has a concrete floor, blockwork walls and an eaves height of approx. 5.6 metres. Each unit has a loading door measuring 3.9m wide x 5.2m high.

There is ancillary office accommodation and WC facilities. There is mains gas, 3 phase power, water and drainage connected to the property.

Externally, there is a forecourt for parking & loading.
