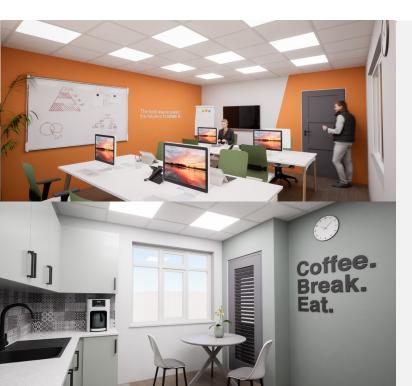

# **Description/Accommodation**

The offices occupy the first and second floors of a three storey mixed retail and office commercial building of traditional construction with brickwork elevations under a pitched slate roof.

The offices form part of a two storey business centre which benefit from communal kitchen/break out area and communal toilet facilities.

First floor rear office: 167 Sq.ft - 16'4" x 10'0".

Second floor office: 2-3 person office - 330 Sq.ft - 18'3" x 18'1".

The second floor office benefits from an external break out area with sofa and chairs and access to toilet facilities.
