Location

The property is located on the well-established Severn Farm Enterprise Park on the outskirts of Welshpool with convenient access to the main A483 Oswestry to Newtown trunk road.

Severn Farm Enterprise Park is situated within the main commercial area of Welshpool approx. 1 mile south of the town centre and is home to a number of local and national businesses. Occupiers in the immediate vicinity include Screwfix, TG Builders Merchants, Tanner Wines and City Electrical Factors.

Welshpool is an important market town and commercial centre within the Mid Wales economy and has a current population of circa 6,000. The town is situated approximately 20 miles west of Shrewsbury and 14 miles northeast of Newtown with Oswestry and Wrexham being approx. 16 and 30 miles respectively via the A458 and A5 trunk roads.

Description

The premises comprise a single storey semi-detached business space/training facility extending in total to approximately 2,964 sqft (275.33 sqm). The property has been fitted out to a modern standard to include suspended ceiling with inset LED lighting, carpeted flooring and gas fired radiator central heating and provides open plan training accommodation with separate storage and loading facilities.

The property also has the benefit of generous forecourt parking and loading facilities with small mezzanine above and is deemed suitable for a variety of uses, subject to planning.

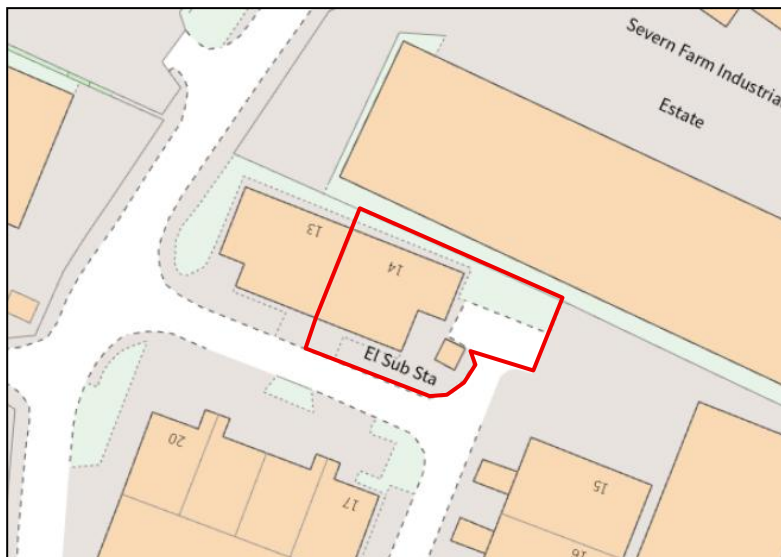
