LOCATION

The units are located on Hale Trading Estate, Lower Church Lane, Tipton. Lower Church Lane is accessed from the main A461 Dudley to Great Bridge Road and a short distance from Great Bridge centre. The M5 motorway at Junction 2 lies approximately 4 miles away and provides access to the M5 motorway and the Black Country national motorway network.

The main A41 Black Country New Road dual carriageway gives access between Wolverhampton City Centre and the M5 motorway.

SPECIFICATION

The units are of steel portal frame construction with profile steel cladding above brick and blockwork to approximately 2m. The units have a concrete floor and an insulated and lined roof with intermittent translucent rooflights and fluorescent strip lighting. Vehicular access is via roller shutter door to the front elevation. The units have WC facilities.
