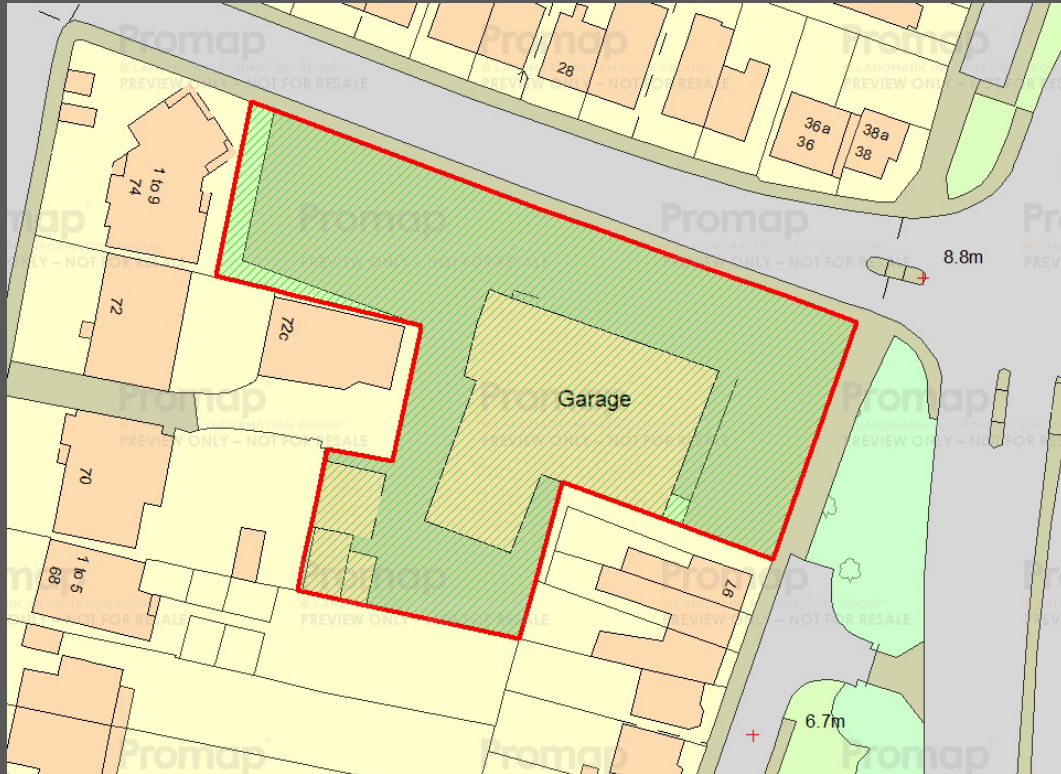

Location

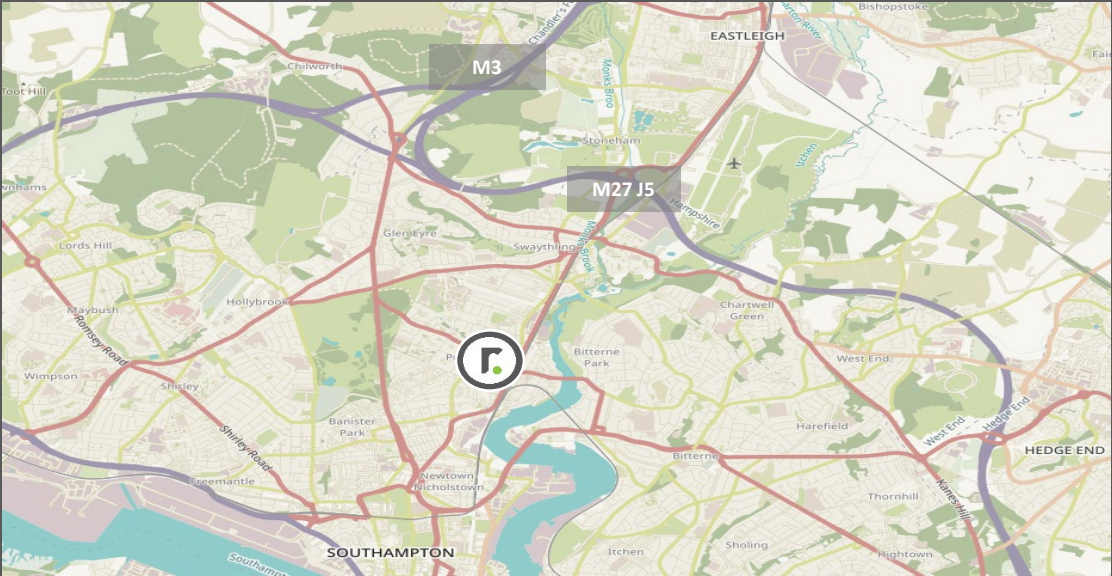
The premises are prominently located at the junction of St Denys Road and the A335 Thomas Lewis Way.

The site sits 2.5 miles south of Junction 5 of the M27 and 1.2 miles north of Southampton City Centre via the A335 main arterial route between the two.

Local amenities including shops, banks and restaurants are located a 5 minute walk westwards along St Denys Road to Portswood Centre.

St Denys Railway Station is located a 5 minute walk south from the site. Southampton Airport and Southampton Airport Parkway Mainline Station is located 2.8 miles to the north.
