## Description

The property comprises a contained industrial/warehouse building which for many years has been occupied by HSS Hire. The property has a trade counter to the front elevation directly facing Edinburgh Way. To the rear of the trade counter area are further offices and staff welfare facilities beyond which there is main industrial/warehousing floor space. Externally there is car parking to the west elevation and a yard to the rear.

#### Location

The Property is situated within the main out of town retail, motor trade and trade counter area close to the junction of Edinburgh Way with North Place.

Harlow is an expanding town with a resident population of circa 93,000.

The town is served by two railway stations the nearest of which to the subject premises is at Harlow Mill serving London's Liverpool Street via Tottenham Hale (Victoria Line). The property is also within 4 miles of Junction 7a of the M11 motorway which intersects with the M25 at Junction 27. Road links are further enhanced by the A414 serving the A1 to the west and Chelmsford to the east.

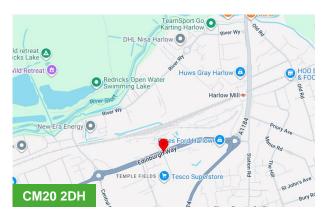
