### Description

Unit 2 Apex Park offers modern, comfort cooled, self-contained office accommodation arranged over ground and first floor levels. The ground floor comprises reception area, a large open plan office, 3 glass fronted offices and kitchenette.

The first floor, accessed via the central staircase or lift comprises predominantly open plan office accommodation with a large meeting room with bifold partitioning, two further glass fronted meeting rooms and a kitchen/staff room.

The building benefits from comfort cooling, raised floor boxes, suspended ceilings, double glazing to all elevations, LED lighting and toilets to both ground and first floor.

The unit comes with generous parking provision of 29 allocated car parking spaces (1:208 sq ft) and additional availability by way of a licence.

## Location

Apex Park is an established business park less than half a mile of J6 of the M5 and 4 miles north of Worcester city centre. The location affords excellent access to the national motorway network, Worcester city centre and the Birmingham conurbation.

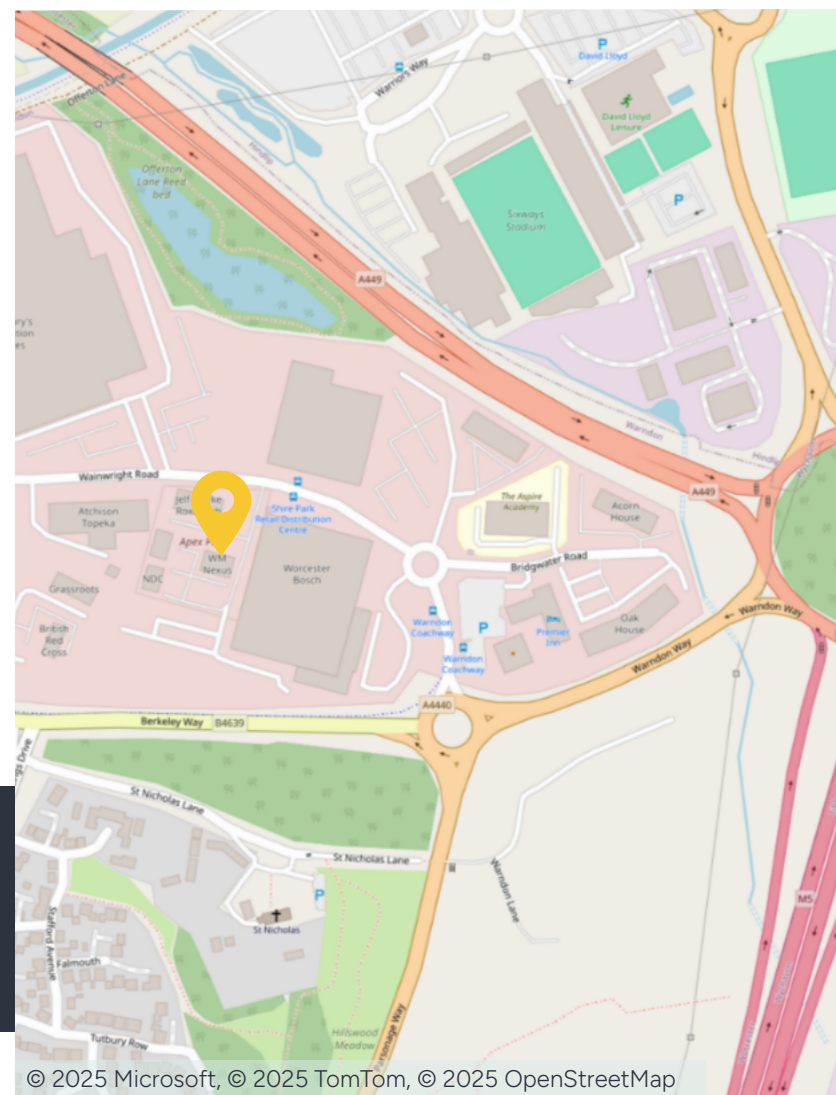
