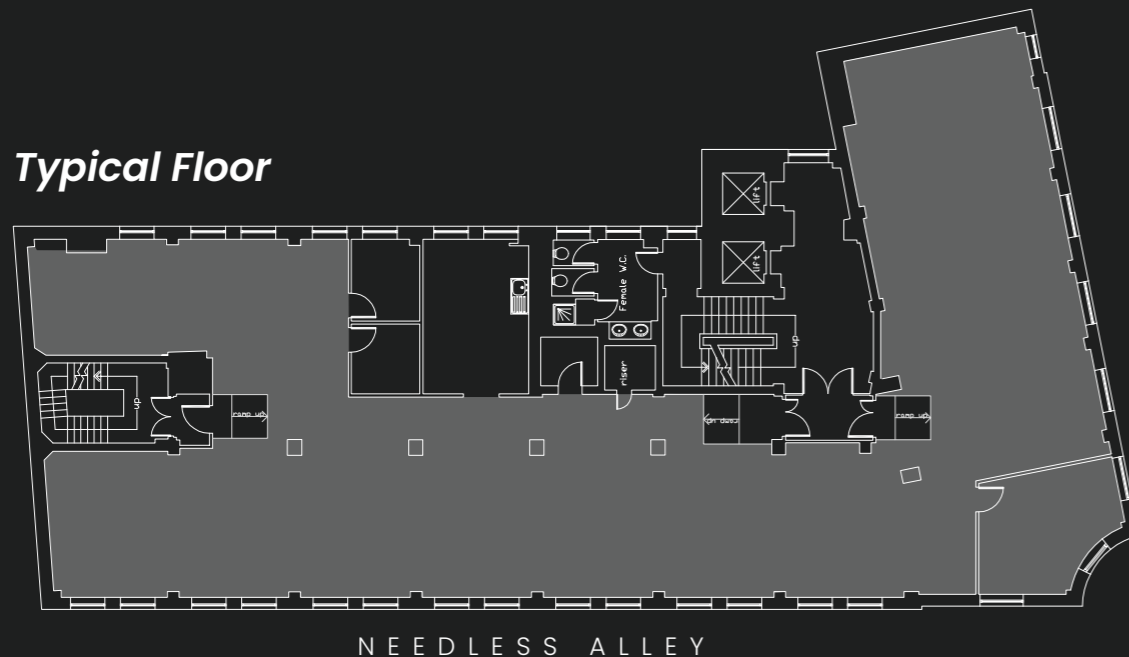
3rd Floor

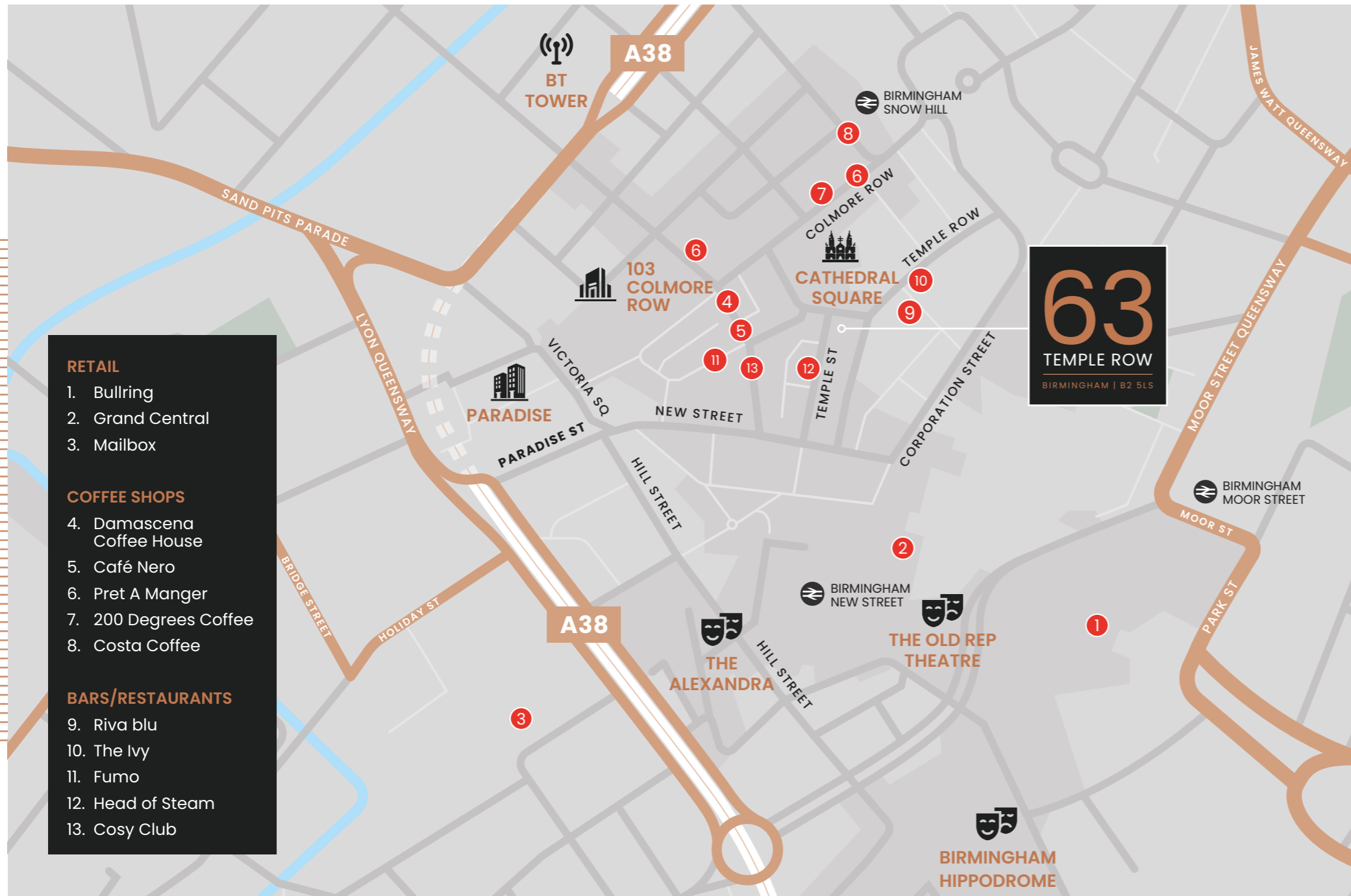


LOCATION
