



FREEPORT

Knowsley 442 sits within the Liverpool City Region Freeport Zone and, therefore, eligible businesses' can apply for Custom Site Operator (CSO) status, which would allow them to take advantage of duty suspension, duty exemptions on re-exports and flexibility on how duty is calculated as well as simplified customs procedures to import, export, store or process goods, and streamlined processes for bringing goods into and moving goods between customs sites.
