LOCATION

Plantation Road forms part of Newstead Industrial Estate in Trentham, Stoke on Trent. Trentham Road provides direct access to the A50 via Stanley Matthews Way (1.5miles), A500 (2miles) to the North and A34 to the West (1.5miles). The A500 provides links to the further Towns of Stoke on Trent and Newcastle under Lyme whilst the A50 links to Uttoxeter and Staffordshire Moorlands.

The premises sit approx.. 4 miles from Junction 15 M6 Motorway providing further connections to Manchester and Birmingham.

DESCRIPTION

The property is of portal frame construction with part brick and part clad elevations. Bay 1 shown on the plans hashed in red is occupied. The remaining space benefits from;

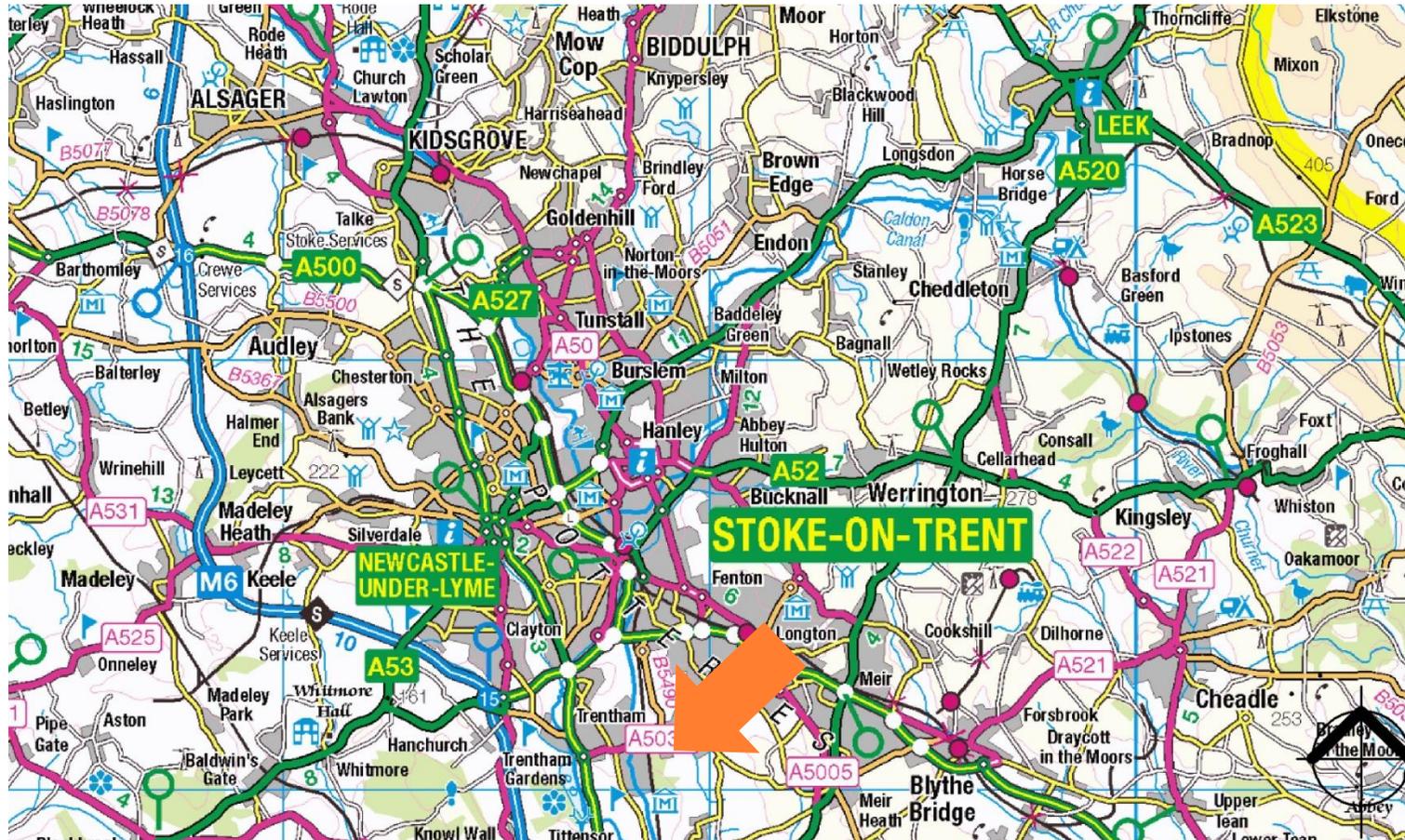
