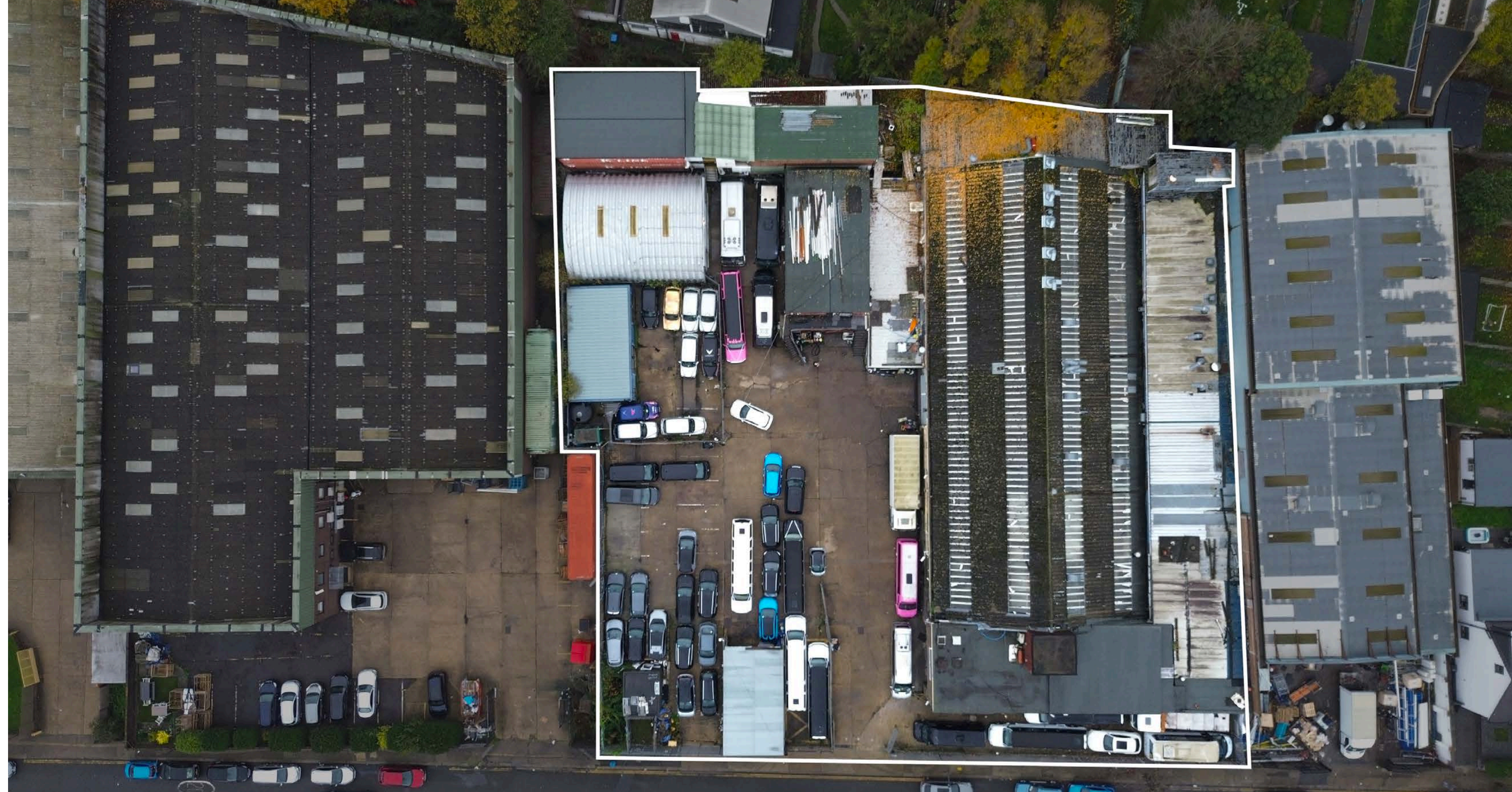

# EXECUTIVE SUMMARY

- 39 Humber Road comprises a freehold site extending to approximately 1.01 acres in the established Staples Corner commercial and logistics district in North West London.
- The site includes Ionna House, a vacant industrial building extending to approximately 29,715 sq ft (2,760.59 sq m), arranged over ground, first and second floors.
- In addition, there are container and yard units which benefit from a combined passing of £70,000 per annum.
- Humber Road is situated adjacent to the Brent Cross Regeneration Area, a multi-billion-pound development.
- Offers are invited in the region of £6,500,000, Subject to Contract, for the Freehold Interest.





# LOCATION

The property is located on the west side of Humber Road, just off the A5 Edgware Road, within the established Staples Corner / Cricklewood commercial and industrial district. Nearby occupiers include Brent Cross Shopping Centre, Homesense, Decathlon, Dreams, Wing Yip, Magnet and a range of logistics and trade counter operators.

The wider area is benefitting from the ongoing Brent Cross Regeneration programme, which will deliver 6,700 new homes, 3 million sq ft of workspace, new transport infrastructure and enhanced public realm.

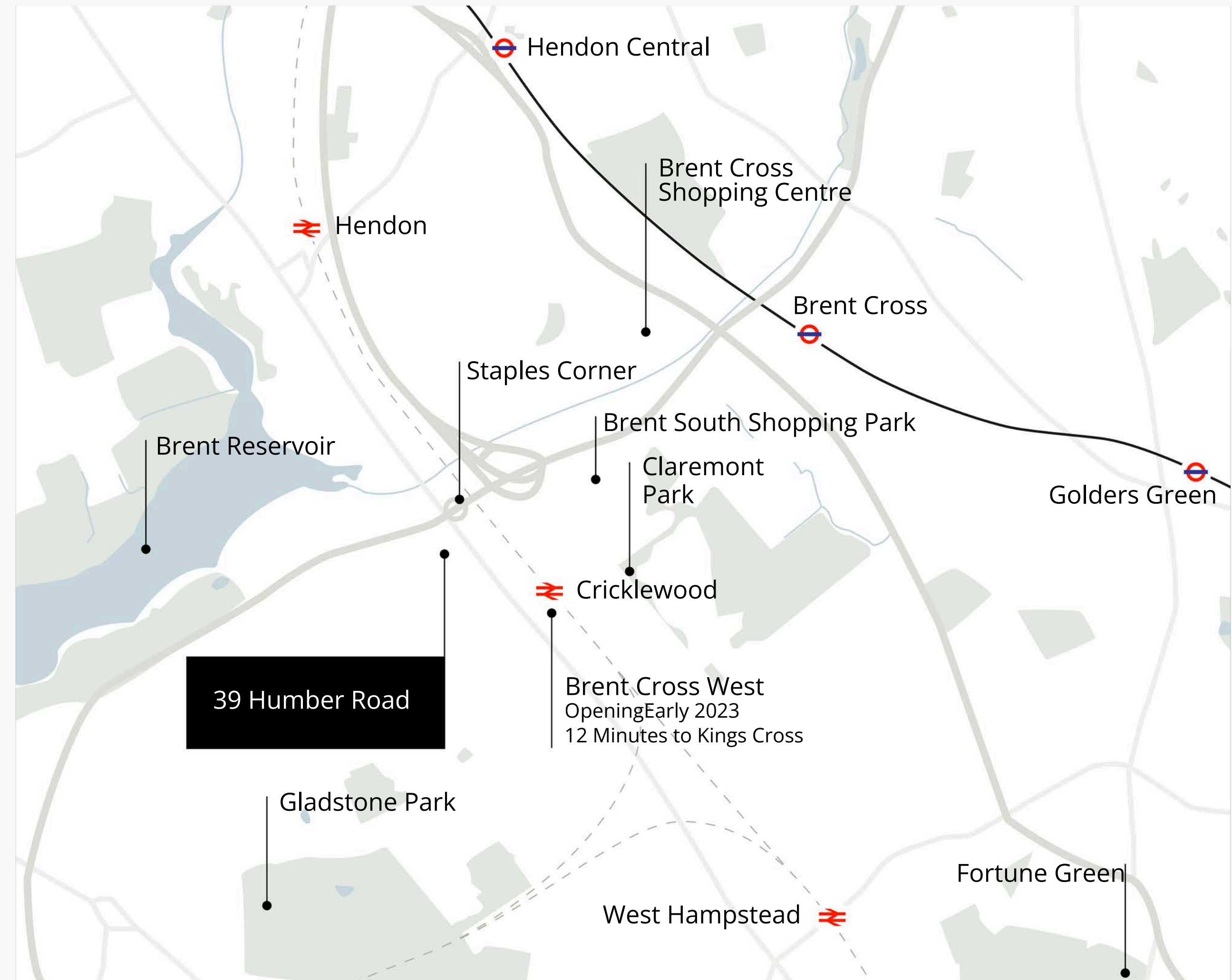

## IONNA HOUSE (39 HUMBER ROAD)

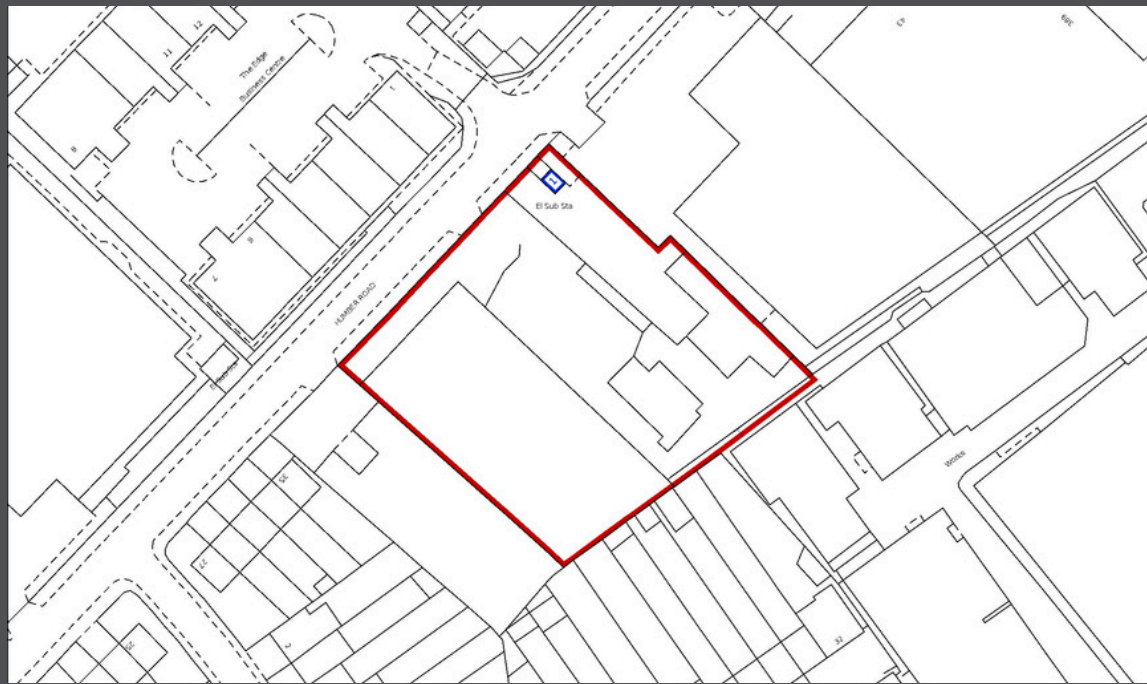
