## LOCATION

Kirklands Business Park is located immediately off the A500 'D' road. The A50 dual carriageway is approximately 1.2 miles, whilst Hanley City Centre is approximately 1.7 miles.

## DESCRIPTION

The property consists of a two storey building with external rendered elevations (due to be redecorated) under a pitched tiled roof. There is parking on the shared yard for approximately 6 vehicles and secured with gates at the entrance.

The ground floor consists of two workshops, one with double door access, the other with a single door access, with an internal connecting door.

The protruding first floor section is accessed from the external spiral staircase, leading into an area currently used as a showroom but could also be offices, with laminate flooring, plastered ceilings and LED lighting. To the rear is an office, kitchen and access through to two further offices and ladies & gents WCs, making up the remainder of the first floor. There is a second staircase to the left side of the building from the yard. Benefits include:

- ✓ Intruder alarm (in part)

Note that a ground floor corner unit No.7 does not form part of the demise.

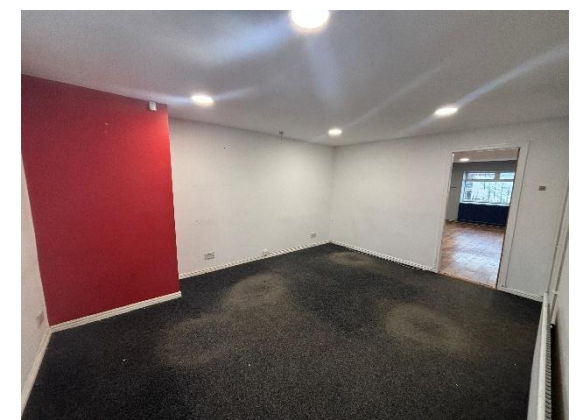
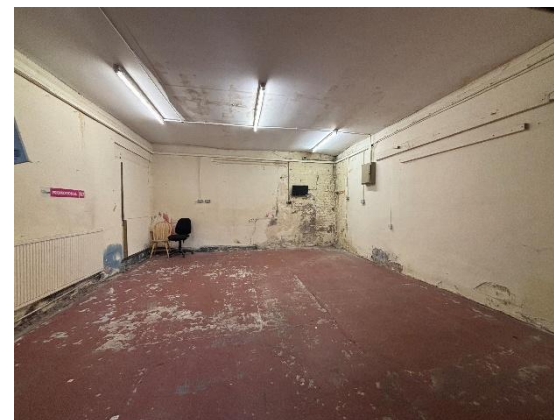
