



New Parade is a 1960s block of seven retail units with residential accommodation over. There is a customer car park to the front.

Unit 6 is a ground floor, open plan, lock up shop with a single WC and loading doors to the rear. The rear estate road offers access, via a communal stairwell and walkway, to the self-contained first floor flat, and to the single garage allocated to the property.










Location
