

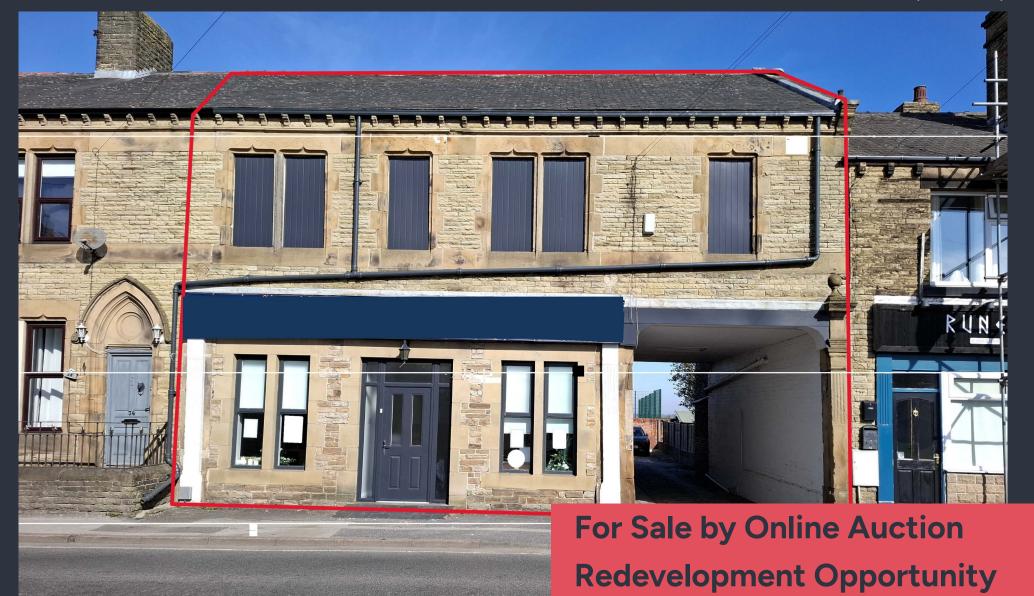

## Description

The mid terraced property comprises of a former funeral director's on the ground floor with a vacant first floor. The property is of brick construction with stonework frontage, under a pitched roof and flat roof to the rear extension.

Internally, the ground floor comprises of reception area, office space, family meeting room, chapels of rest, kitchen and storage space. The space has been recently decorated throughout and is fitted

with plaster painted walls, carpet and laminate flooring and LED spotlights.

The first floor has very limited access from the ground floor kitchen. Access to the staircase in the kitchen is currently via a whole cut into the breeze block wall separating the kitchen and access point. Having said that, we did manage to gain access to the first floor.

This floor comprises two large open plan rooms,
The area has been left vacant for a substantial
period of time and isn't currently fitted with any
services including lighting or electricity/gas. Substantial works including roof works will be required

for the property to be habitable to the first floor.

The first floor is completed stripped out with exposed brick and smashed windows.

Externally, there is a yard to the rear of the property which is currently used for car parking. There are rights of access to residential properties on both sides of the building.

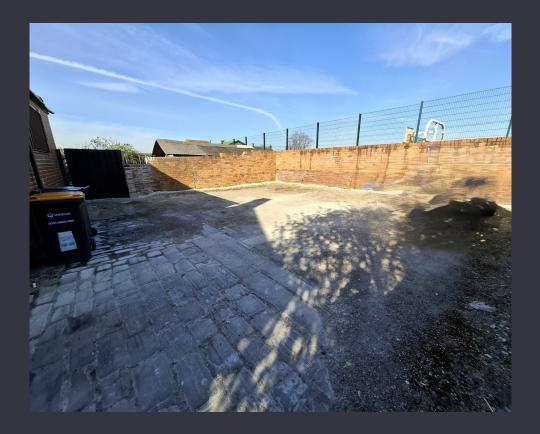
