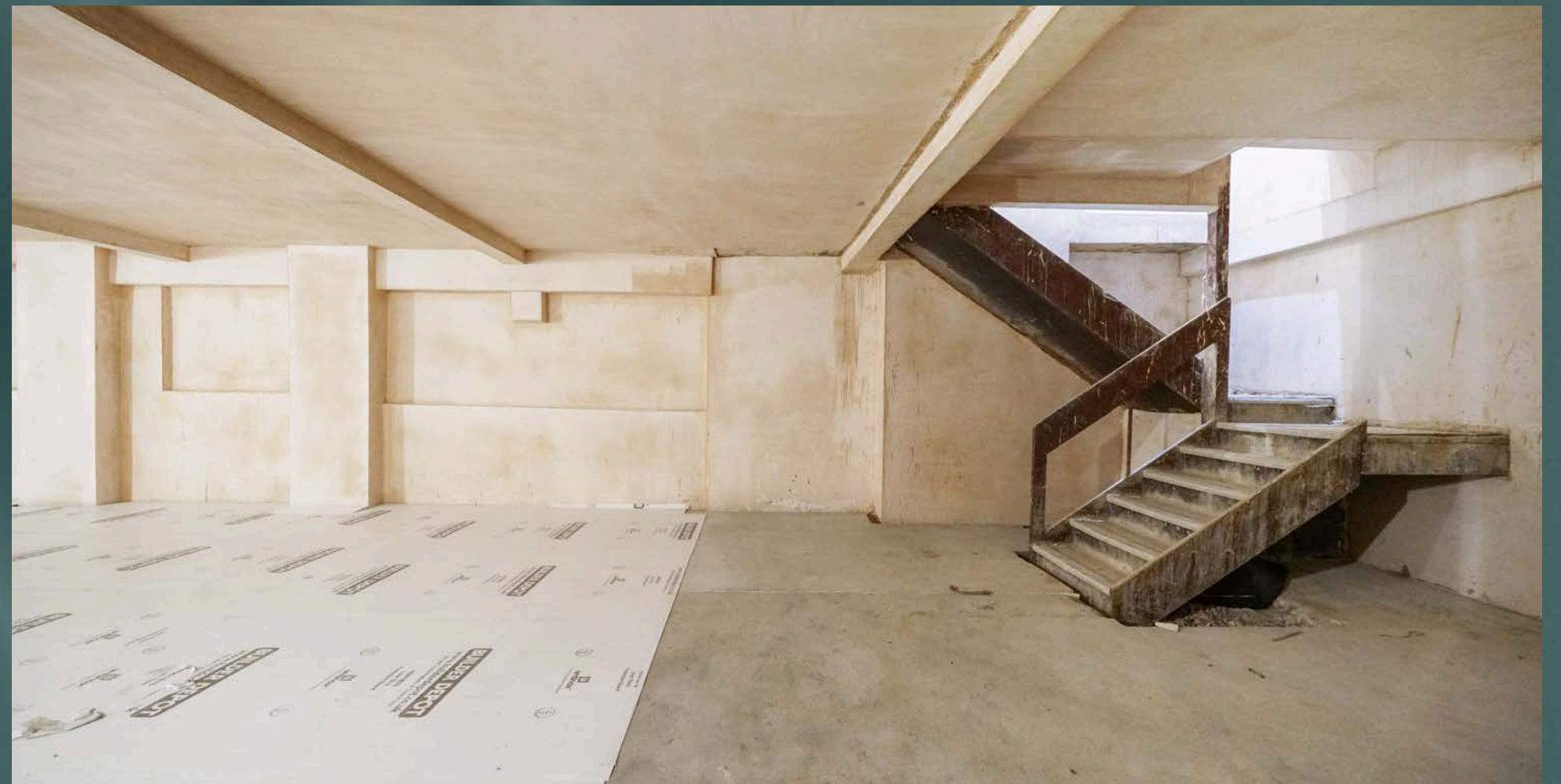
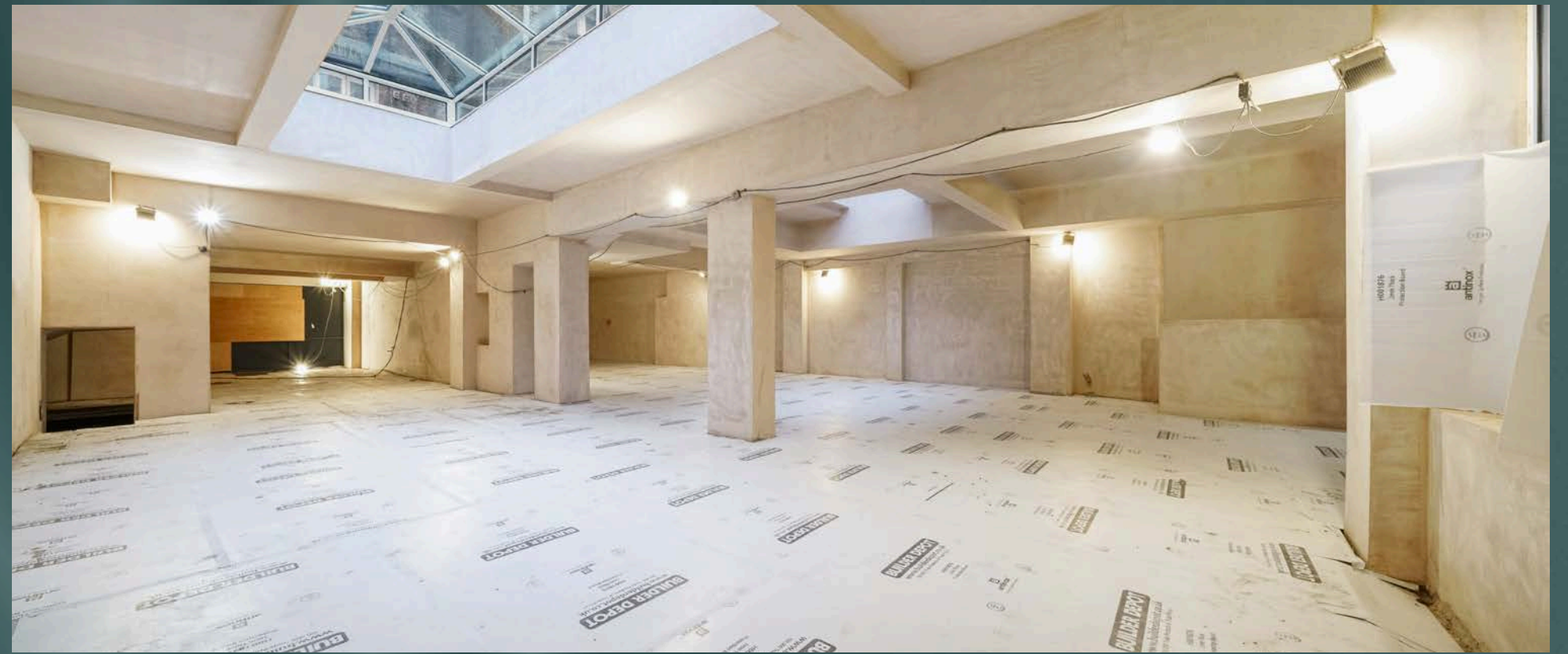
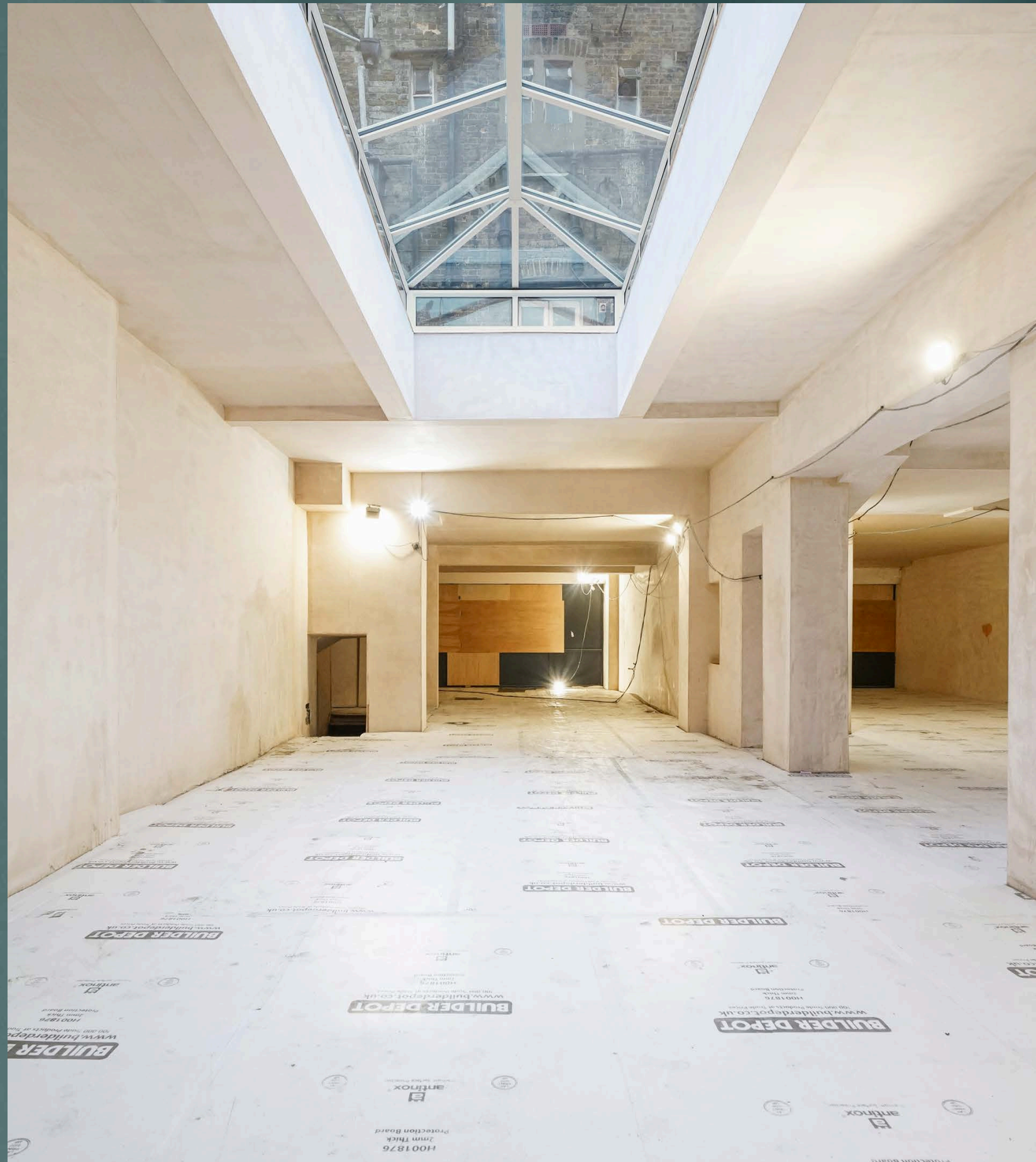
DESCRIPTION

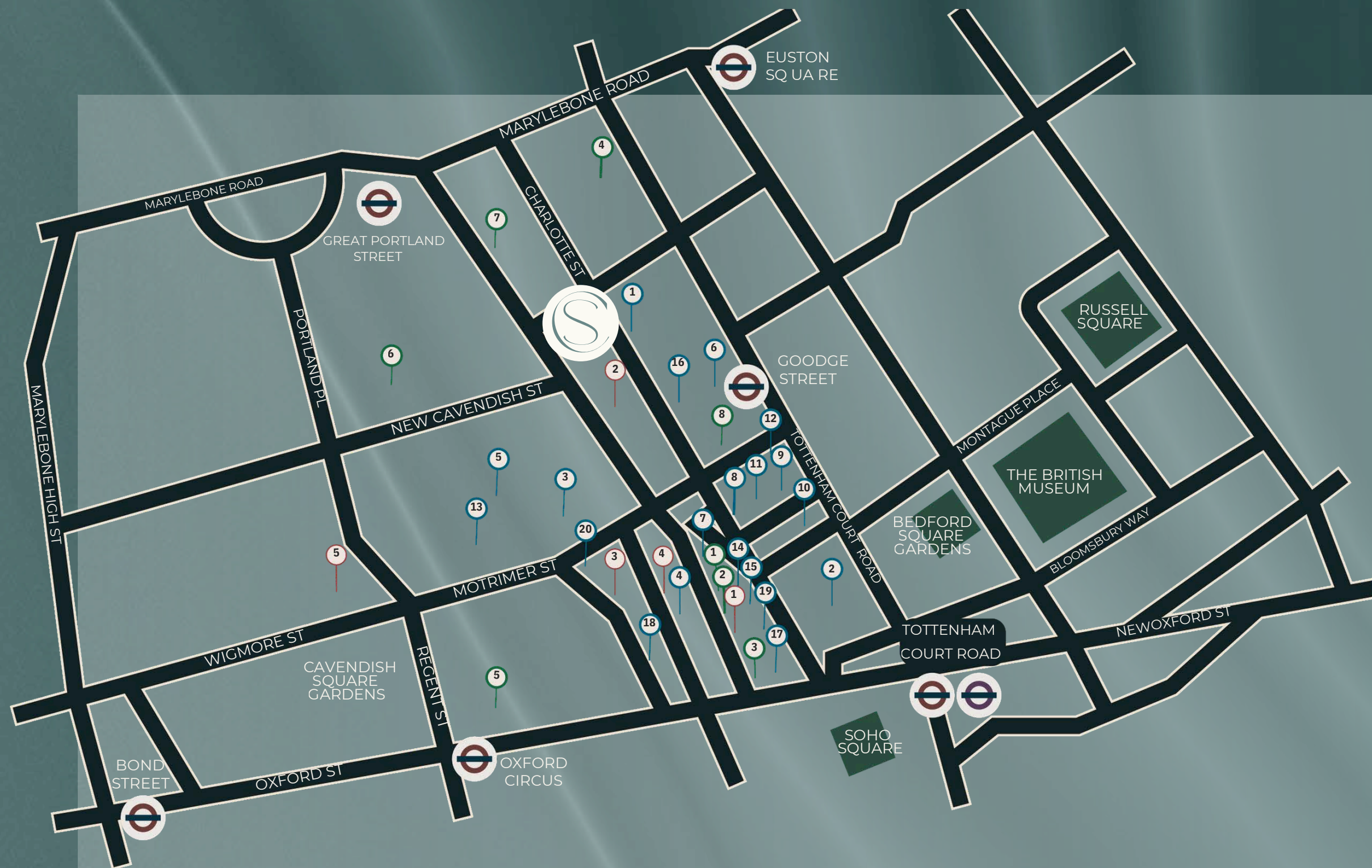

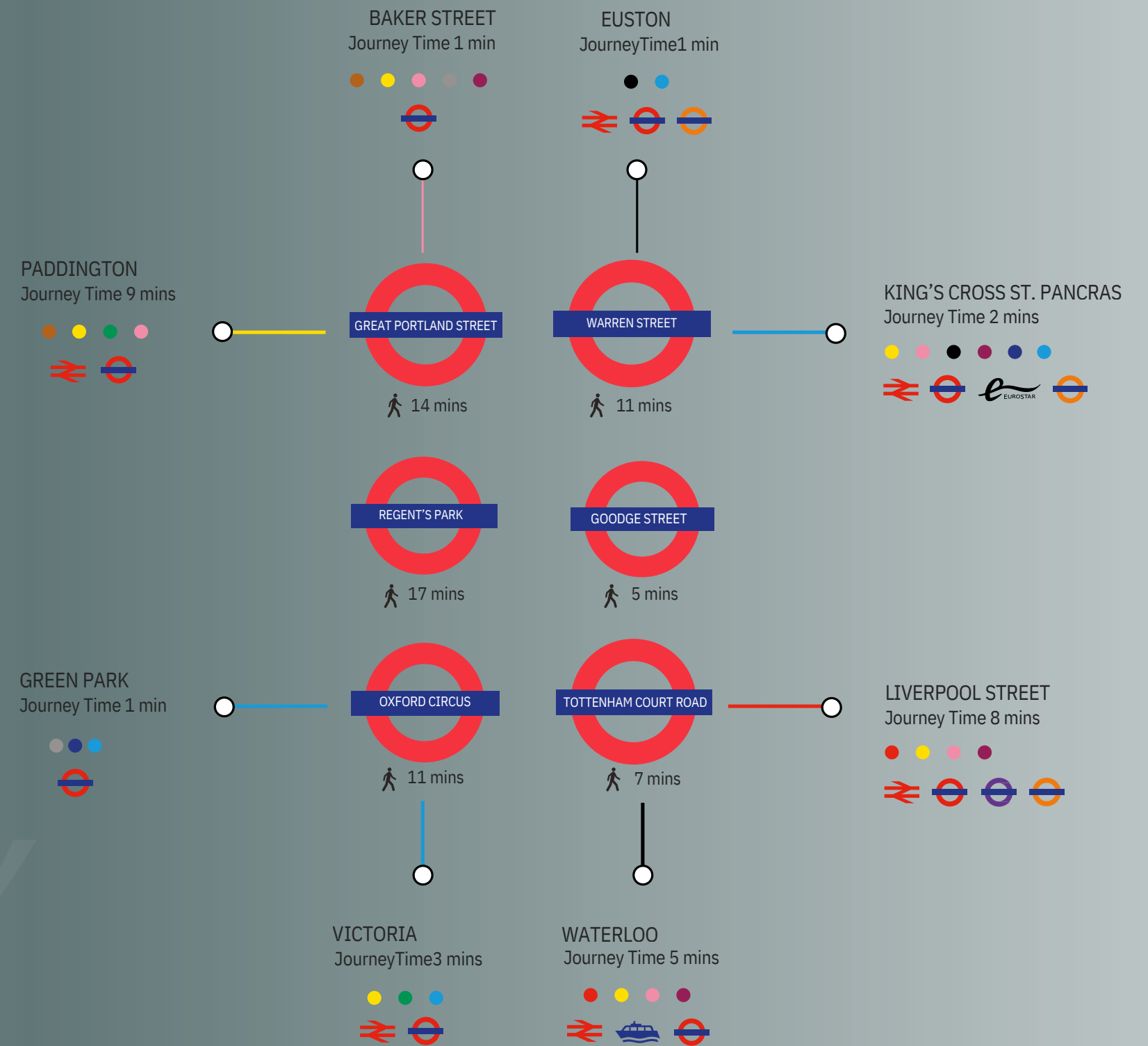

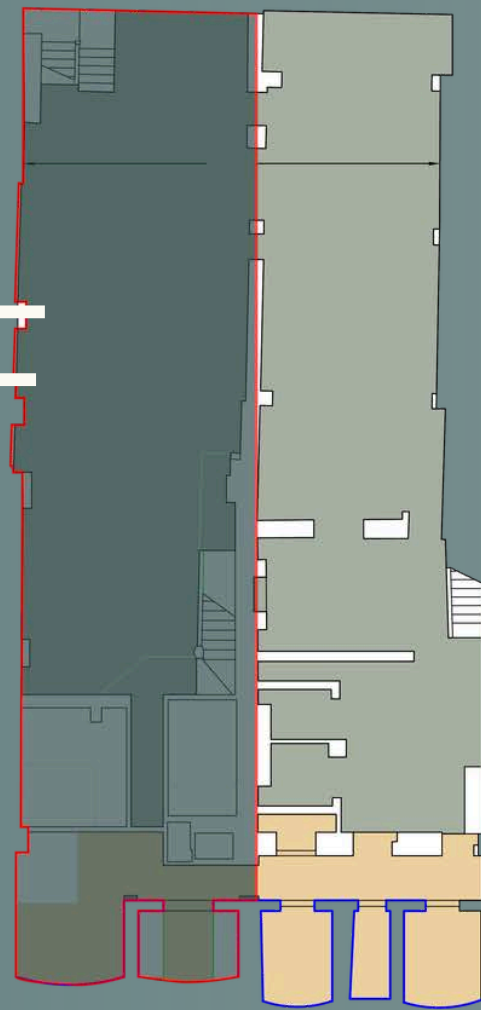

Floor plans are not to scale and are for indicative purposes only.

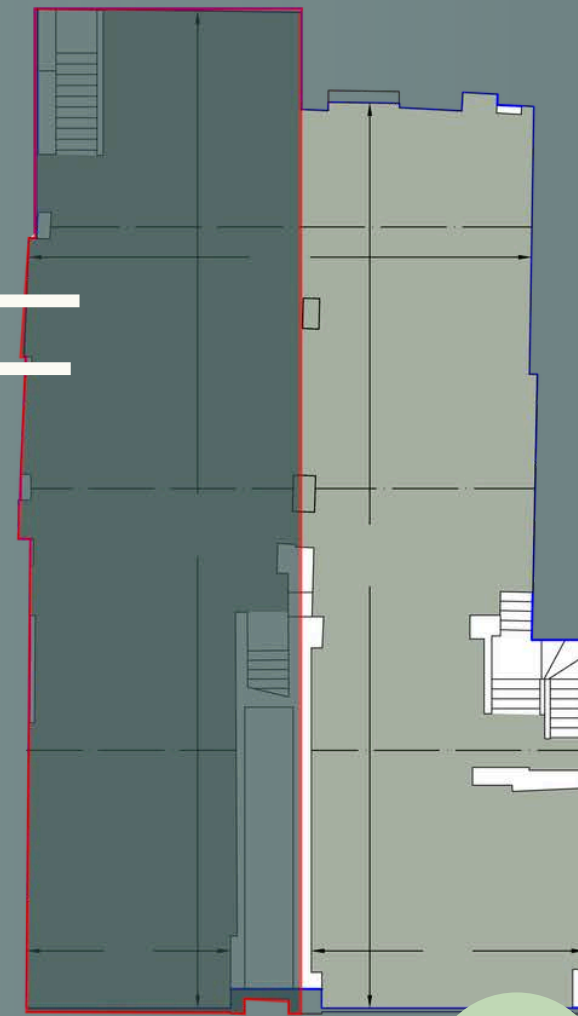
