# **Description**

The property comprises a traditional mid terrace building with a concrete tiled timber framed roof and is of solid brick construction.

The accommodation provides ground and first floor retail/stores and office space. The property benefits from a small disabled WC at ground floor level and a small kitchen to the rear of the property. At first floor there are two separate offices and further WC facilities.

Externally, there is a small yard which is accessed from the kitchen and there is also direct access to the rear lane from the rear storeroom.

We understand the property benefits from electric and water services, however, we recommend that any interested party carries out their own investigations with regard to this matter.

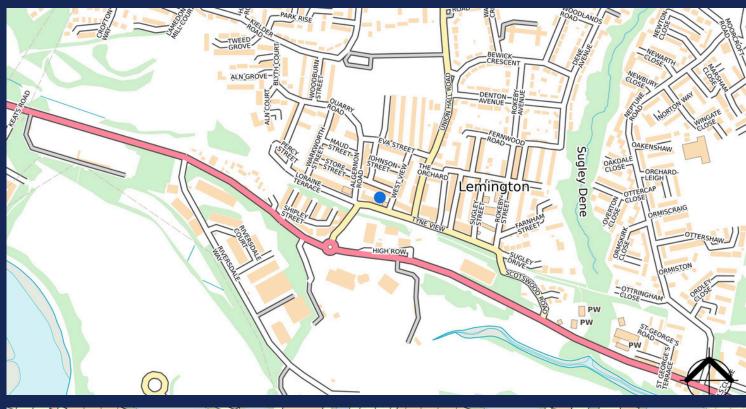
### **Use/Planning**
