




Description

The property is currently vacant and measures 6,757 sq.ft on approximately 0.24 acres (0.1 hectares). The site is bordered by industrial buildings on three sides and the railway line to the east. The property was previously occupied by art studios used as BI(c) space, now under the E(g) use class.

Location

The property is located in the industrial area of West Norwood in South London. It's just 0.2 miles from West Norwood Train Station, which offers regular services to London Victoria (23 minutes) and London Bridge (25 minutes). The property is a short walk from the high street on Knight's Hill, which is home to numerous shops, restaurants, pubs, and offices. Additionally, it is close to West Norwood Cemetery, providing 40 acres of open space. The area is well-served by London bus routes and provides connections to Brixton and the London Underground Victoria line.
