LOCATION

The property is located on Kingsland Grange, with immediate access to Junction 21 of the M6 (1.25 miles away) and less than 2 miles away from Junction 11 of the M62. The grange employment area comprises over 200 acres and is a strategically located employment area in serving the wider North West region.

The property is easily accessed off Woolston Grange Avenue which runs between Birchwood Way & Manchester Road with access to M6 & M62.

Surrounding occupiers include Thermo Fisher Scientific, Buddha Group Limited, Panther Logistics & Vodafone.

DESCRIPTION

The property comprises a self-contained detached industrial unit of steel portal frame construction with brick/blockwork elevations and profile metal cladding. The warehouse benefits from level access loading, gas warm air blowers and an eaves height of approximately 5.5 metres.

Single-storey offices are located to the front of the unit and are separate from the warehouse, providing well-presented ancillary accommodation. Externally, the property offers a secure gated yard, dedicated car parking and significant scope for expansion.
