Externally, the unit benefits from a tarmac surface loading and parking area to the rear. The property is available for occupation from June 2025.

Kemble Airfield offers a secure business environment conveniently positioned 15 minutes from Cirencester and 30 minutes from Swindon. The property benefits from good motorway connections, being just 12 miles from J.17 of the M4 and 20 miles from J.13 of the M5. There is also a railway station just 5 minutes from the property offering regular connections to Swindon, Cheltenham and Gloucester.
