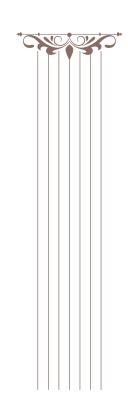






# APSLEY HOUSE

Standing proudly within the Colmore Business District, Apsley House is a prestigious and handsome, 19<sup>th</sup> Century, Grade II listed office building.



Having been originally designed as a private residence, the architectural features displayed on the splendid façade now conceal four floors of modern office space. A later extension provides additional office accommodation set around an internal courtyard, while extensive storage facilities can be found in the basement. With predominantly open-plan office space, air-conditioning, a passenger lift connecting all upper floors and situated in the city centre, Aspley House is eminently suitable for a range of discerning occupiers.







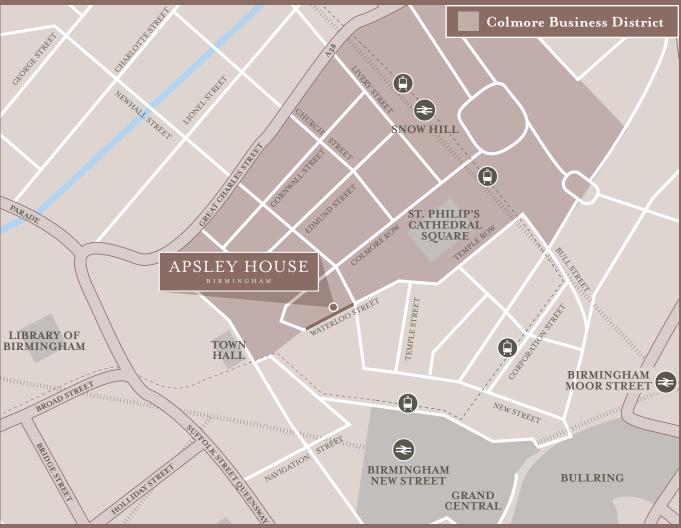
