Braintree is a popular commuter location for individuals, serving both London and Stansted Airport. It has a regular rail service to London (Liverpool Street) with a fastest journey time of approximately 60 minutes. The town, and particularly this specific location, enjoys excellent road communications being situated adjacent to the A120 and A131 trunk roads. The A120 provides access to Stansted Airport and Junction 8 of the M11 westwards: thereafter the M11 provides access south to the M25 and north to Cambridge, the A1M and A14.

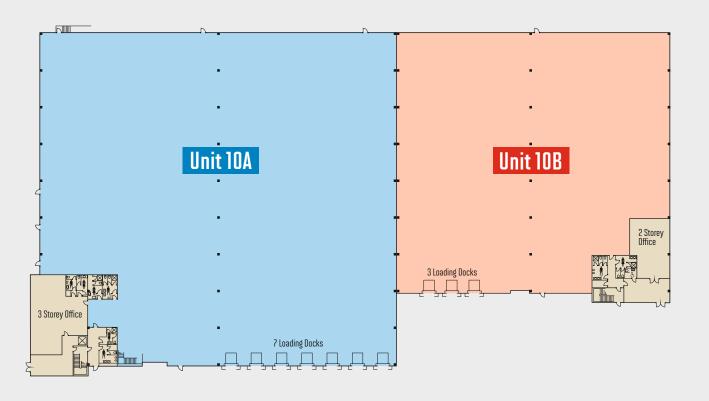
THE BUILDING(S)

The buildings known as 10A & 10B both benefit from independent office accommodation and a 10m eaves height to haunch but are fully interconnected if required.

Unit 10A has seven dock levellers and one level access door, Unit 10B has three dock levellers and one level access door.

The office accommodation and overall warehousing is currently being refurbished.
