## Location

The site is prominently positioned on Leicester Lane (A445) on the north-eastern edge of Cubbington, approximately 2.5 miles from Royal Leamington Spa town centre. This accessible and well-connected location provides direct links to the A445, with swift onward access to the A46, M40, and the wider Warwickshire and West Midlands region.

Situated within an established semi-rural corridor, the area benefits from a blend of open landscape and nearby residential communities, offering an attractive yet practical setting for future development. Surrounding towns including Leamington Spa, Kenilworth, Warwick, and Coventry are all within easy reach, supporting strong labour catchment, supply-chain access, and amenity provision.

The postcode sits within a stable and well-regarded part of Warwickshire, with local services, schools, and commercial centers located a short distance away. The site enjoys good visibility from Leicester Lane and convenient vehicular access, enhancing its suitability for a range of commercial or redevelopment uses, subject to planning.

## Description

The property comprises approximately 5 acres of land situated on the northern edge of Cubbington, fronting Leicester Lane (A445). The site is currently laid to a mix of hard standing and banded landscaping, with secure gated access directly off Leicester Lane. It is understood to be brownfield land, historically used by Warwickshire County Council as a source of materials, which supports its potential for redevelopment subject to planning.

Previously operated as a council depot and materials site, the land has long been associated with infrastructure and operational use. Its legacy as a working site contributes to its brownfield designation, offering a strong planning narrative for future development. The presence of existing hard standing and banded areas reflects its former industrial utility and provides a practical base for new schemes (subject to further land investigations).

The site presents a compelling opportunity for a range of uses, including:

- Commercial or industrial development
- Storage and logistics
- Mixed-use schemes
- Renewable energy or infrastructure projects
- Residential

Its scale, access, and location make it suitable for both standalone operations and multi-unit layouts. The brownfield status may support favorable planning outcomes, especially in the context of regional growth and land supply pressures.

## Planning History
