LOCATION

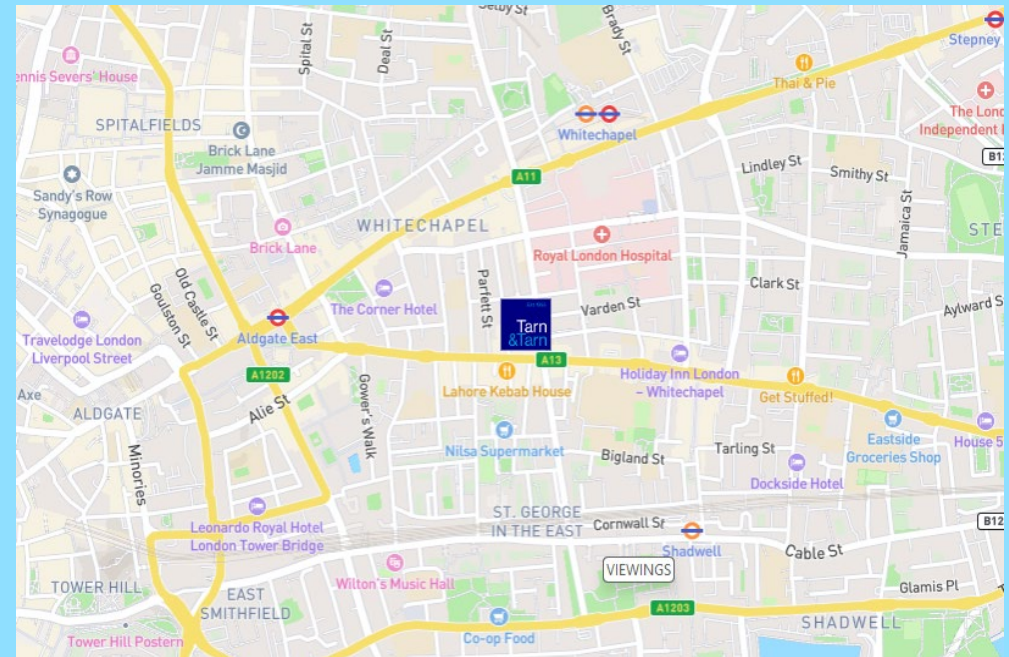
THE AREA
