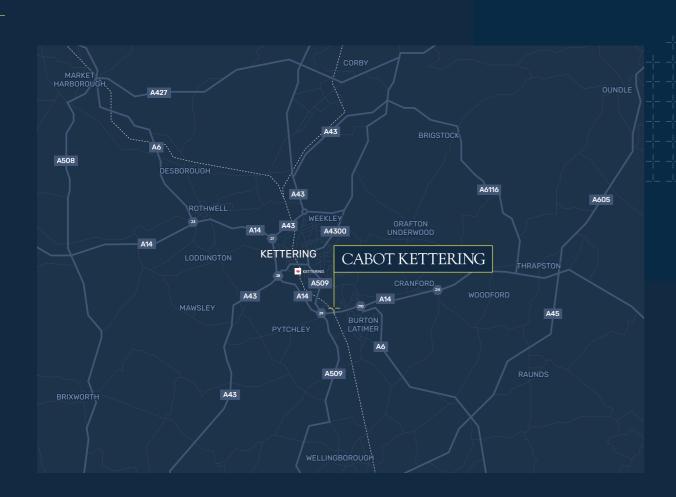




GOLDEN TRIANGLE LOCATION
