Description

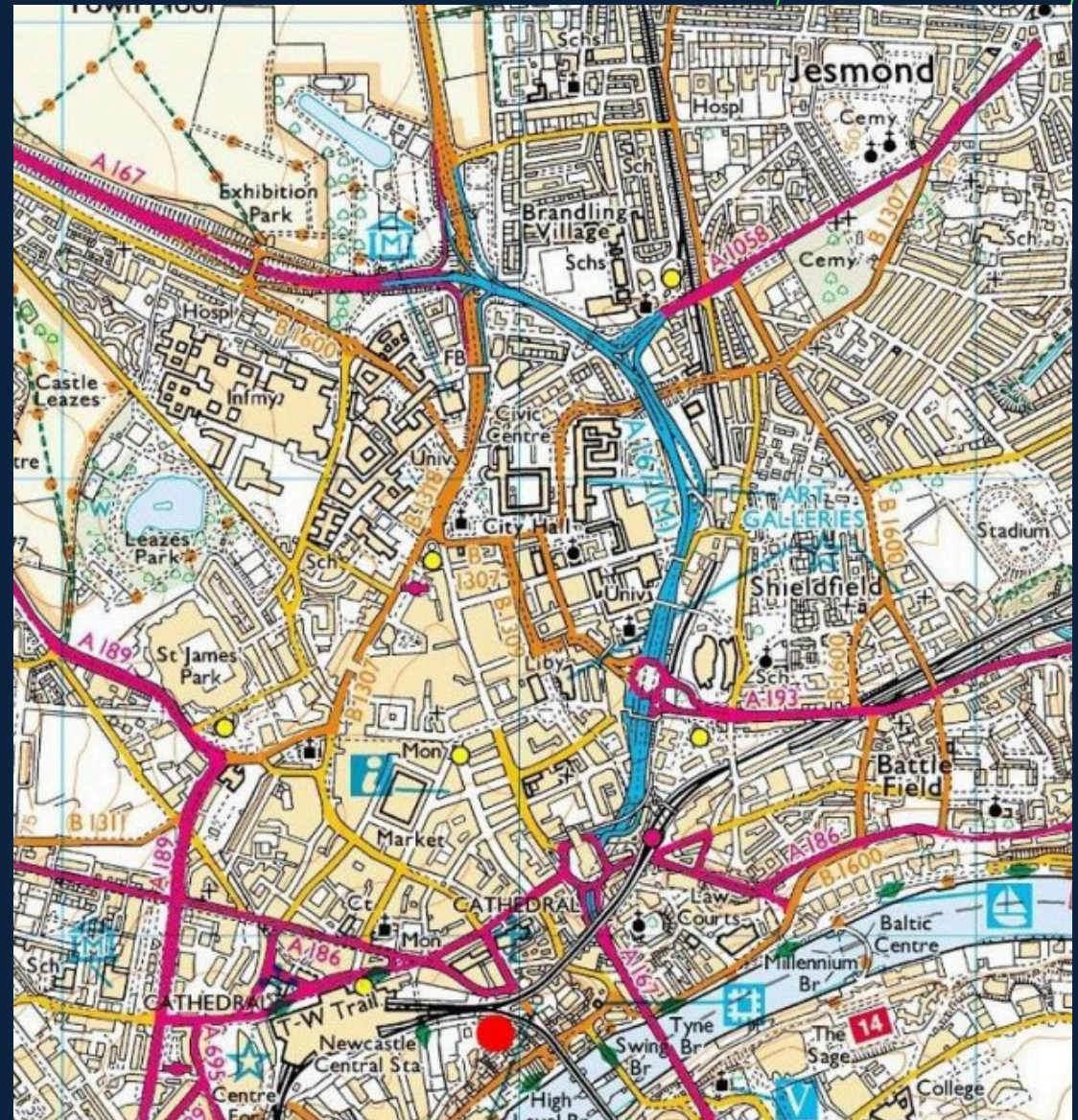
Contemporary recently refurbished double fronted unit comprised over two floor plates. The unit benefits from double glazed shop frontage with excellent visibility facing directly onto Forth Street, internal electric roller shutters for additional security, level concrete floor, WC facilities with hot water heater and new LED lighting throughout. As part of the refurbishment, a heating and cooling air conditioning system has been installed. Arches 13 & 14 have been amalgamated to form one double unit which would be suitable to accommodate majority of operator requirements.



Occupiers in the nearby vicinity include Telegraph Pub, Sorcerer Café, Cavavin, Roomz Hotel, Four Points Flex Hotel, Grosvenor Casino, French Quarter amongst numerous others. Central Square North / South Grade A office buildings sit approximately 200 yards away from the subject property which houses national firms with well in excess of 1,000 staff members.

Location

The property is situated on Forth Street only a short 2 minute walk from Central Station which has been the subject of significant investment extending the external and public realm areas with a programme of pedestrianisation in order to create a sense of arrival and a true gateway to the city centre. There are a variety of commercial uses in close proximity including Grade A office accommodation, bars & restaurants and retail establishments. Nearby occupiers include The Boiler Shop, The Pattern Shop, Four Points Hotel, Tokyo Bar, Nandos, Manhattan amongst numerous other national and local operators.

Asking Rent & Lease Terms

The property has consent for E Use Class under the Town & Country Planning Use Classes Order as amended 1 September 2020.

Insurance
