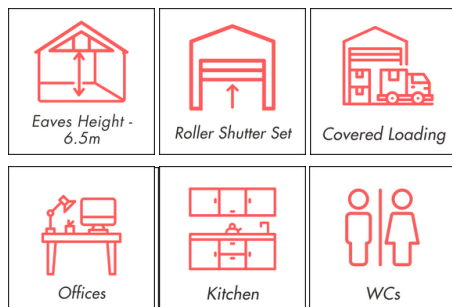

DESCRIPTION

The property comprises a mid-terraced single storey factory/warehouse of portal frame construction under an insulated roof incorporating rooflights. The warehouse offers highly efficient clear span working space with a single level access loading door that emerges onto a covered loading bay.

Offices are provided at ground and first floor, with ladies and gents WC's and a kitchen/breakout facility.

The unit occupies a mid-terraced position within the estate, fronting the principal estate road.

LOCATION




Stevenage is situated approximately 30 miles north of London, 15 miles north of the M25 (J23) and 15 miles east of Luton. The town benefits from a mainline station providing direct links to London Kings Cross and St Pancras with a journey time of less than 30 minutes.

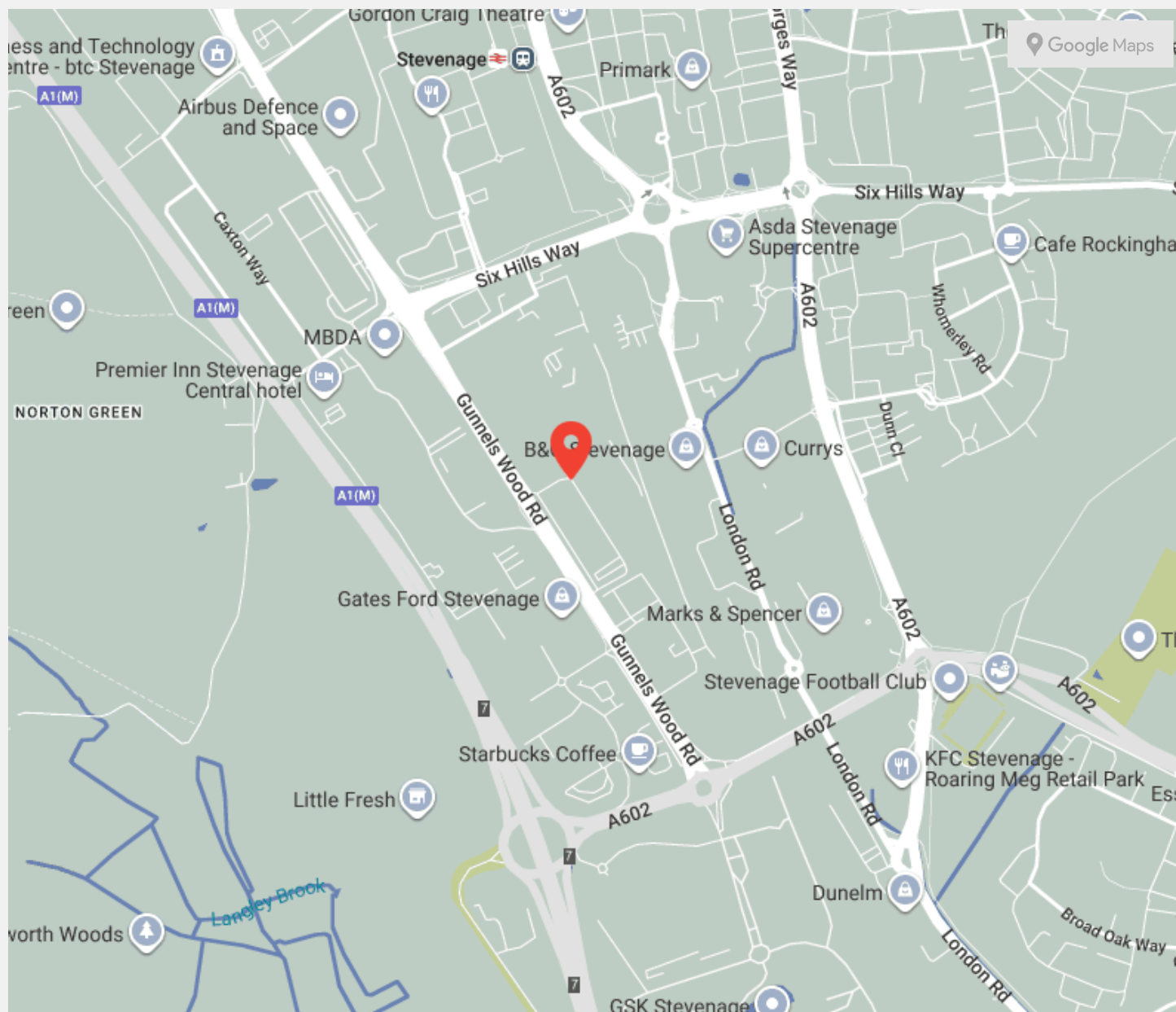
Gunnels Wood Park is located in the heart of Stevenage's principal business area within convenient walking distance of the town centre and station, which are less than 1 mile from the property. Junction 7 of the A1(M) is just half a mile away from the estate.

TERMS

The unit is held on a lease for a term expiring in March 2033 at a current rent of £144,850 per annum exclusive, equating to less than £10psf. The rent is subject to review in March 2028 when there is also a simultaneous tenants option to break. The lease is available for assignment, or alternatively, on the basis of an underlease until March 2028. 6 months' rent free is available subject to status.
