Planning permissions was previously granted (BH2017/01118) for a rooftop restaurant. various common areas within the building have been recently refurbished examples of which can be seen in the photos.

Location

Tower Point is located in a central position in Brighton City Centre between Brighton Station & the seafront on the periphery of The North Laine area. Beneath the building are both an NCP Car Park & a Pure Gym Health Club. Other nearby operators include Tesco Express & Greggs as well as local operators such as Julien Plumart, The Pond, La Choza, Jeremy Hoyer & Gresham Blake.

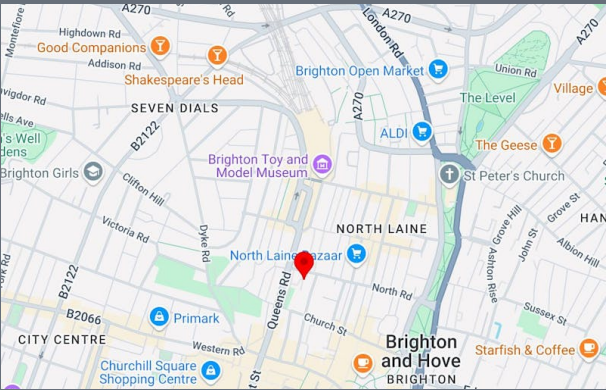

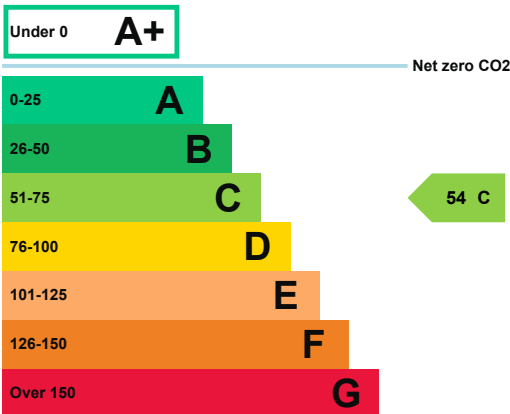
