Oswestry is a major North Shropshire market town situated on the fringe of the English and Welsh border located approx. 18 miles north west of Shrewsbury, 30 miles south of Chester and 28 miles from Newtown, and serves a wide catchment area.

Description

The site comprises a level, secure development opportunity extending to approximately 0.51 acres (0.206 hectares) or thereabouts.
