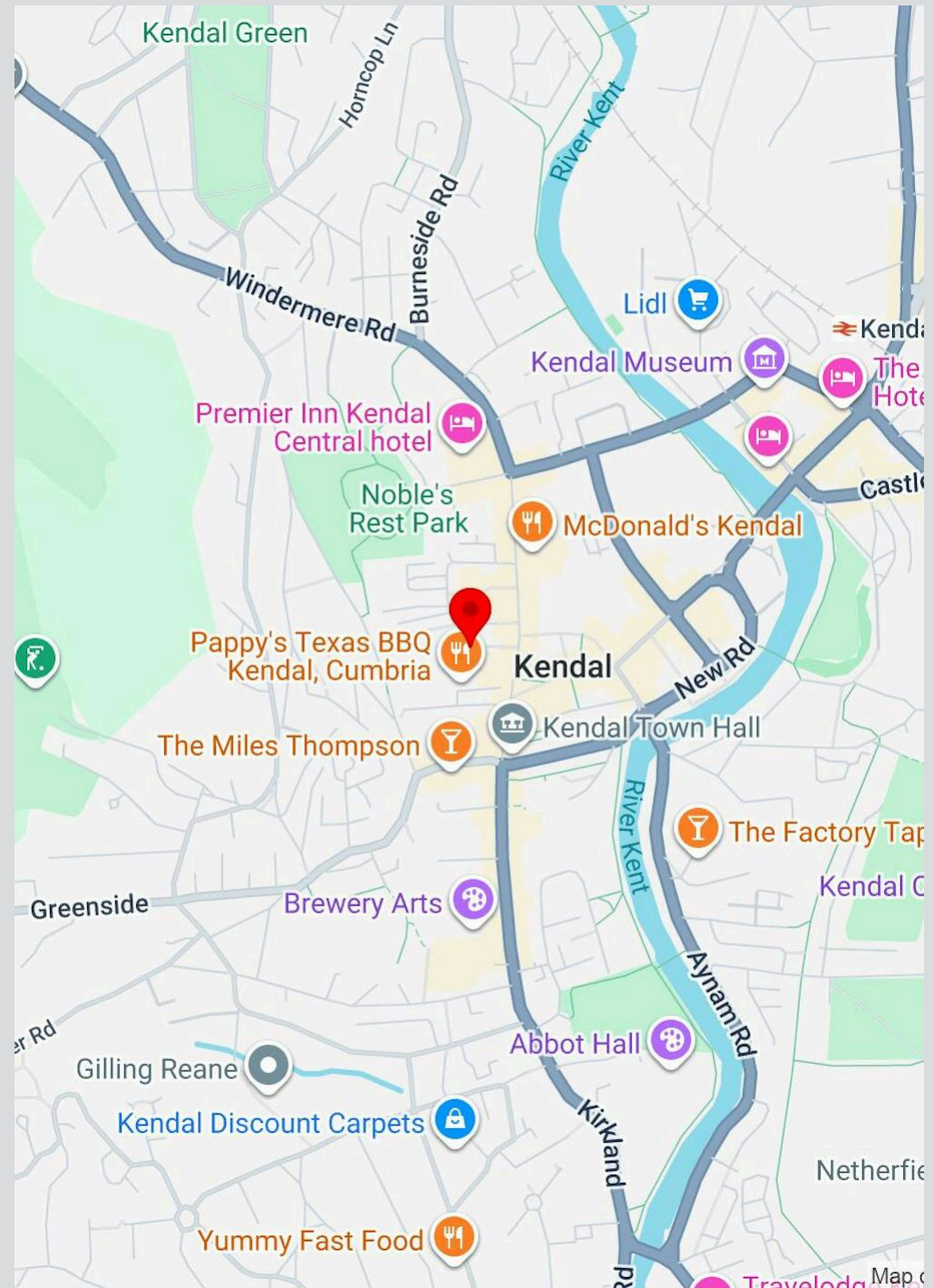

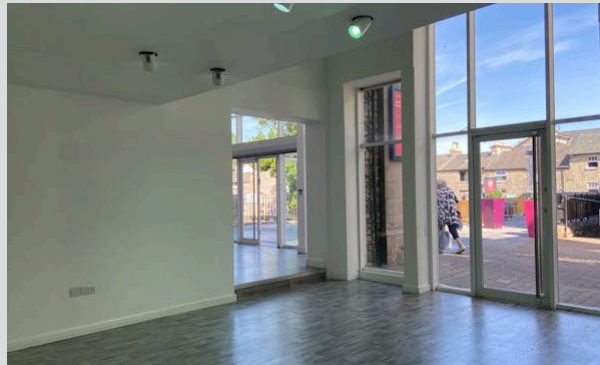
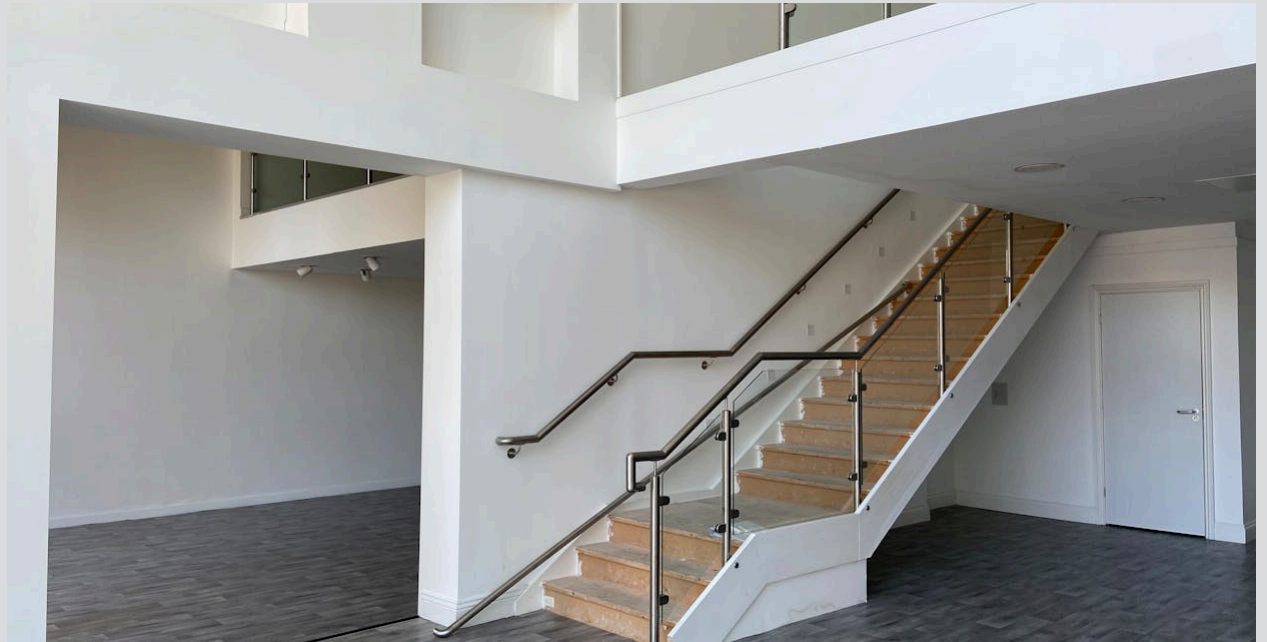


LOCATION
