Description

The subject property comprises a predominantly self-contained industrial unit which has been lightly refurbished.

The property is made up of three separate units which have been combined internally. The units are predominantly of brickwork construction, with some steel profile cladding on the upper elevations. Internally, the unit provides open plan warehousing/workshop space, a small office suite and additional mezzanine storage.

Externally, the unit benefits from a secured yard/parking area to the side of the property and three loading doors.

Location

The property is centrally located in St Philips, Bristol. The unit benefits from excellent transport links being just 0.8 miles from the M32, providing access to the M4/M5 interchange. It is also just a 10 minute walk from Bristol's principle train station, Bristol Temple Meads.
