Description

The premises comprise a semi-detached unit constructed with a traditional steel portal frame and clad with insulated profile metal sheet to the elevations and roof. The roof also benefits from approximately 20% roof lights. The external elevations are part profile metal sheet and brickwork, with powder coated double glazed windows to the offices. The main estate road, car park to the front of the building and the yard area to the side elevation are block paved. The site boundary to the motorway is protected via a wooden fence and to the rear boundary is a wire mesh fence.

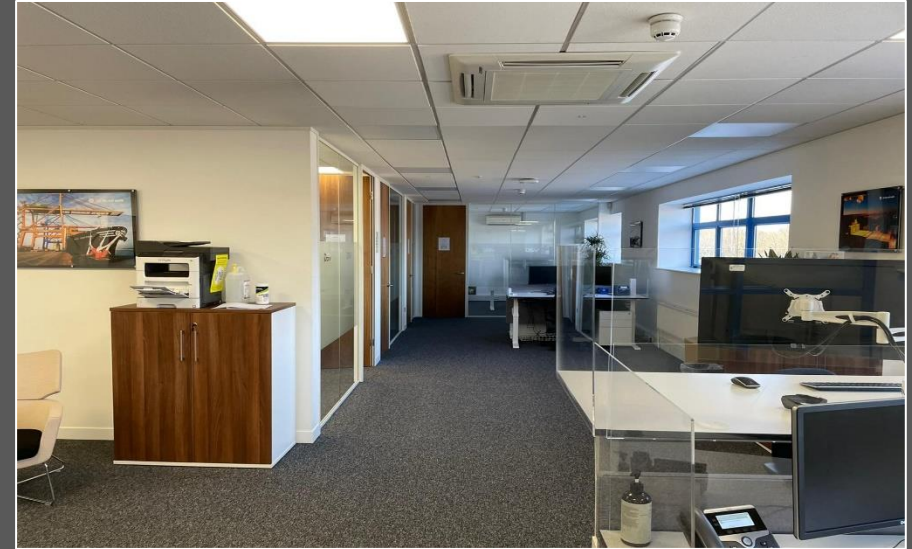

Location

The unit is located on Airways Distribution Park overlooking the M27 motorway and is accessed off George Curl Way. George Curl Way links with the A335 which provides direct access to Junction 5 M27, Southampton International Airport and Southampton Airport Parkway Railway Station which is a mainline fast train stop between Southampton Central and London Waterloo. Junction 5 provides excellent access to M27/A31 westbound for Bournemouth and the West Country and M27/A3(M)/A27 eastbound for Portsmouth. Junction 4 connects to the M3 northbound for M25/A34 to London, The Midlands and The North.

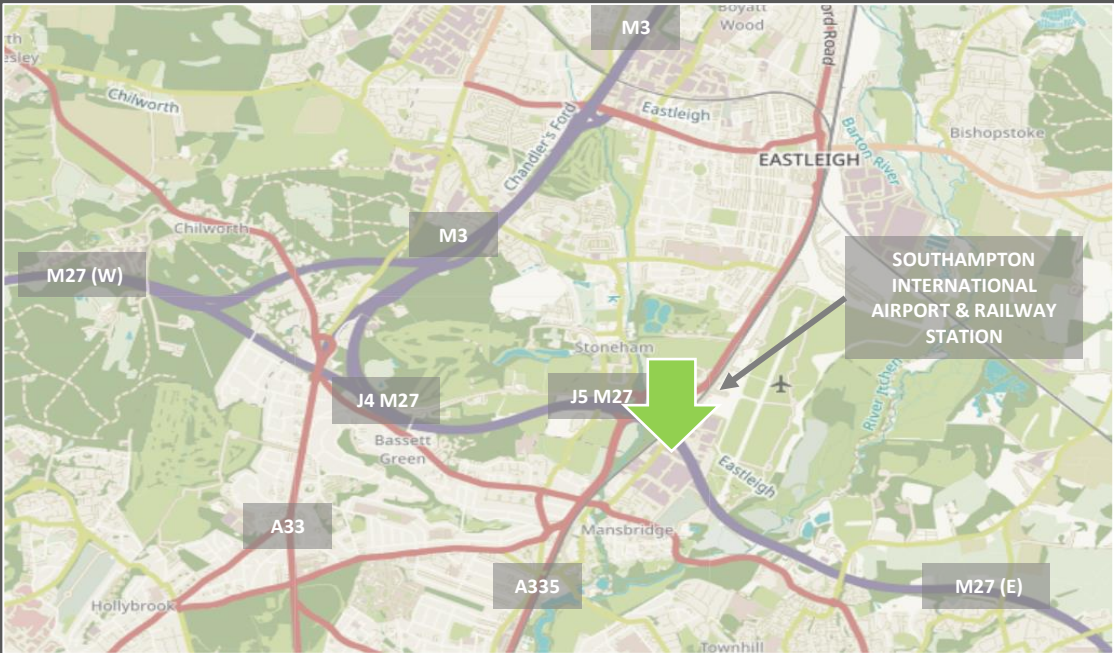
Terms
