#### Location

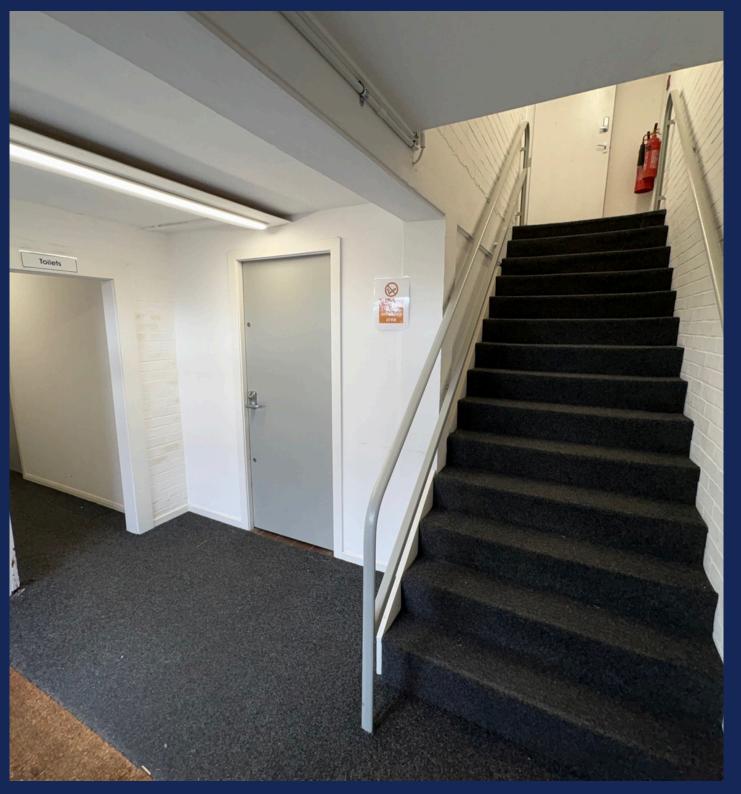
