

Centre for Contemporary Arts (CCA)

The Centre for Contemporary Arts (CCA) in Glasgow is a hub for contemporary arts, hosting exhibitions, performances, film screenings, and cultural events. Located on Sauchiehall Street, the CCA supports emerging and established artists through residencies, workshops, and collaborations. It also provides space for independent artists and organizations to showcase experimental and innovative work, making it a key venue in Scotland's contemporary arts scene.

The CCA now has a 3-year funding package in place from April '25 to March '28 with the venue owners, Creative Scotland. This offers stability for the years going forward, and enables this fdantastic organisation to continue to serve the arts community in Glasgow as well as the rest of Scotland and beyond. This lease will be with the CCA and not Creative Scotland.









The Opportunity

The Centre for Contemporary Arts is seeking an operator to rent the F&B side of their business within the popular CCA on Sauchiehall Street.

This multi-faceted business has the capability to offer food from breakfast through to late night, with an alcohol licence, separate bar with outdoor space and consistent stream of events, galleries and functions within the courtyard, a lot of which with a requirement for catering.

The bar is currently operated by the CCA,, with the cafe offering very much an adhoc pop up with no permanent operation in place. There is no weekend or evening food offering.

Unlike traditional tenancies, there will be an element of working with the owners as they host events and various other functions within the courtyard and greater facility - this will bring the opportunity for additional catering.

The bar currently has a turnover of circa £380,000, operated by the CCA.


