## Description

The available accommodation comprises two identical light industrial/storage units situated within a secure fenced estate at Capstan Park, North Tyneside. The units were originally constructed for boat storage and repairs purposes, however, they are well suited to a variety of storage and light industrial uses given their clear open plan layout and excellent accessibility.

The units present very well throughout and benefit from the following features:

- Modern arched steel clad construction
- Full height electric roller shutter loading access (4.2m wide x 4.2m high)
- Solid concrete flooring
- Secure fenced and gated site
- Monitored CCTV coverage
- 6m max floor to ceiling height
- 100% business rates relief for qualifying businesses
- Excellent access to the A19, Tyne Tunnel and wider North Tyneside area

## Location

Capstan Park occupies a prominent commercial location on Hadrian Road (A187) in Wallsend, North Tyneside. The estate benefits from excellent road connectivity, with direct access to the A19 approximately 2.5 miles to the east via the Tyne Tunnel approach, providing convenient links throughout the North East region, including Newcastle upon Tyne, Sunderland, North Tyneside and the wider national motorway network. Newcastle City Centre lies approximately 4 miles to the west.

The property is situated within an established commercial and industrial area that is home to a range of occupiers across manufacturing, engineering, trade counter, distribution and business services sectors. The location benefits from excellent public transport provision, with Hadrian Road Metro Station located immediately adjacent, providing regular services to Newcastle City Centre, the coast and Newcastle International Airport. Wallsend Town Centre is also nearby, offering a range of retail, leisure and amenity facilities for staff and visitors, making it an attractive base for a variety of occupiers.
