Location

The property occupies a convenient location within Mochdre Industrial Estate with good access to the Newtown bypass and main road network.

Mochdre is the largest of the town's three industrial estates and is home for a wide variety of both local and national companies, including Cellpath, Boys and Boden, NIDEC and Border Holdings.

The estate is located on the south western outskirts of Newtown off the A489 Llanidloes Road and the Newtown Bypass approximately 1.5 miles from the town centre.

Newtown is centrally located in Mid-Wales and is the principal economic and administrative centre for the area being situated approximately 30 miles west of Shrewsbury and 40 miles east of Aberystwyth and serves a wide catchment area.

Description

The property comprises substantial industrial/warehouse facility with separate modular office accommodation and modern steel portal frame building extending in total to approx. 80,890 sqft (7,515 sqm) on a site extending to approx. 7.38 acres (2.99 Hectares) or thereabouts.

The main building is arranged as eight open plan bays having gantry craneage, and has an eaves height of 4.25m. Internally, the property benefits from solid concrete floor, fluorescent strip lighting, gas fired space heater. The facility has 10 roller shutter loading doors accessed from all elevations via a circulation yard.

A further storage building of modern design has been constructed to the rear of the facility providing clear span storage space with interconnecting roller shutter door to the main manufacturing space.

A number of two storey modular office buildings adjoin the western elevation of the property providing both ground and first floor office accommodation, together with staff welfare facilities and reception areas. The units have the benefit of double glazed windows, carpeted floors, suspended ceilings incorporating fluorescent strip lighting and heating throughout. A staff canteen adjoins the northern elevation.

Externally, the property comprises hard standing storage to the south of the site together with a tarmacadam surface car park which can accommodate approx. 100 vehicles.
