#### Location

The property is located at Grange Farm on the outskirts of Woodhurst in the county of Huntingdonshire.

The location offers a countryside setting with good transport connectivity, providing fast and easy access to St Ives, Huntingdon and towns further afield including Cambridge.

The offices at Grange Farm offer excellent connectivity. Huntingdon station is approximately 6.8 miles away, providing a fast rail service to London Kings Cross and St Pancras in under an hour.

There is a bus stop located in Woodhurst providing direct services to Ramsey and Huntingdon with St Ives providing connections to the Cambridge Bus Way, Addenbrookes Hospital and Cambridge City Centre. Woodhurst is located half a mile from the premises.

The A141 is located a mile to the north west of the site connecting the site to the A141. A1 and the wider road network.



# **Description**

The property is situated in a rural setting benefitting from attractive views, ample parking and a private secure driveway.

The office itself is fitted out to a good standard internally. The office comprises a mix of open plan space and separate office/meeting rooms, including a boardroom.

The office suite benefits from modern WCs and kitchen facilities and large windows for natural light.

Externally there is a private car park available with parking for vehicles.

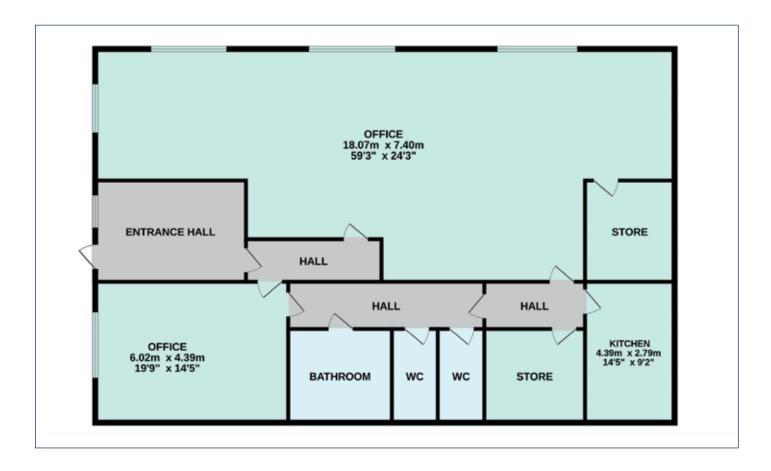
