



## Location

Located at the southern end of Ogden Road, adjacent to Shaw Lane and forms part of the Shaw Lane Industrial Estate which is a well established estate, located to the north-east of Doncaster city centre and well-situated to take advantage of road links to the A18 and A630. Junction 4 of the M18 lies approximately 3 miles to the east.



## **Description**

Detached and self-contained Industrial/Warehouse unit made up of steel portal frame with brickwork and metal clad elevations.

The unit is currently undergoing some refurbishment and any incoming tenant will be consulted to confirm their fit out requirements.

Externally there is hard standing to the front and side of the property with grass to the rear.

The unit was previously occupied by a single tenant but has services available to 4 separate units and 4 individual roller shutter doors allowing each unit to be occupied individually should this be required.

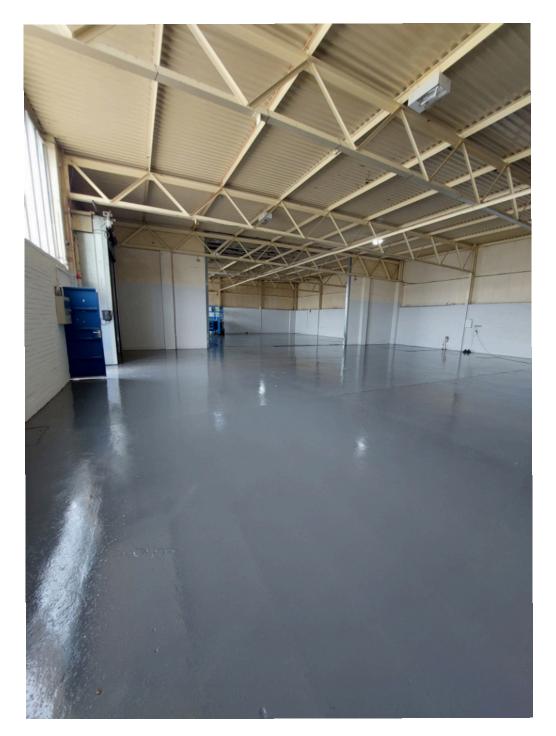

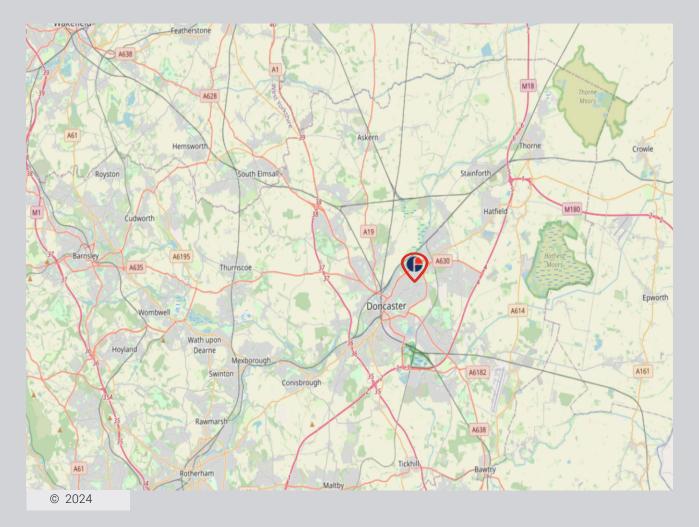
