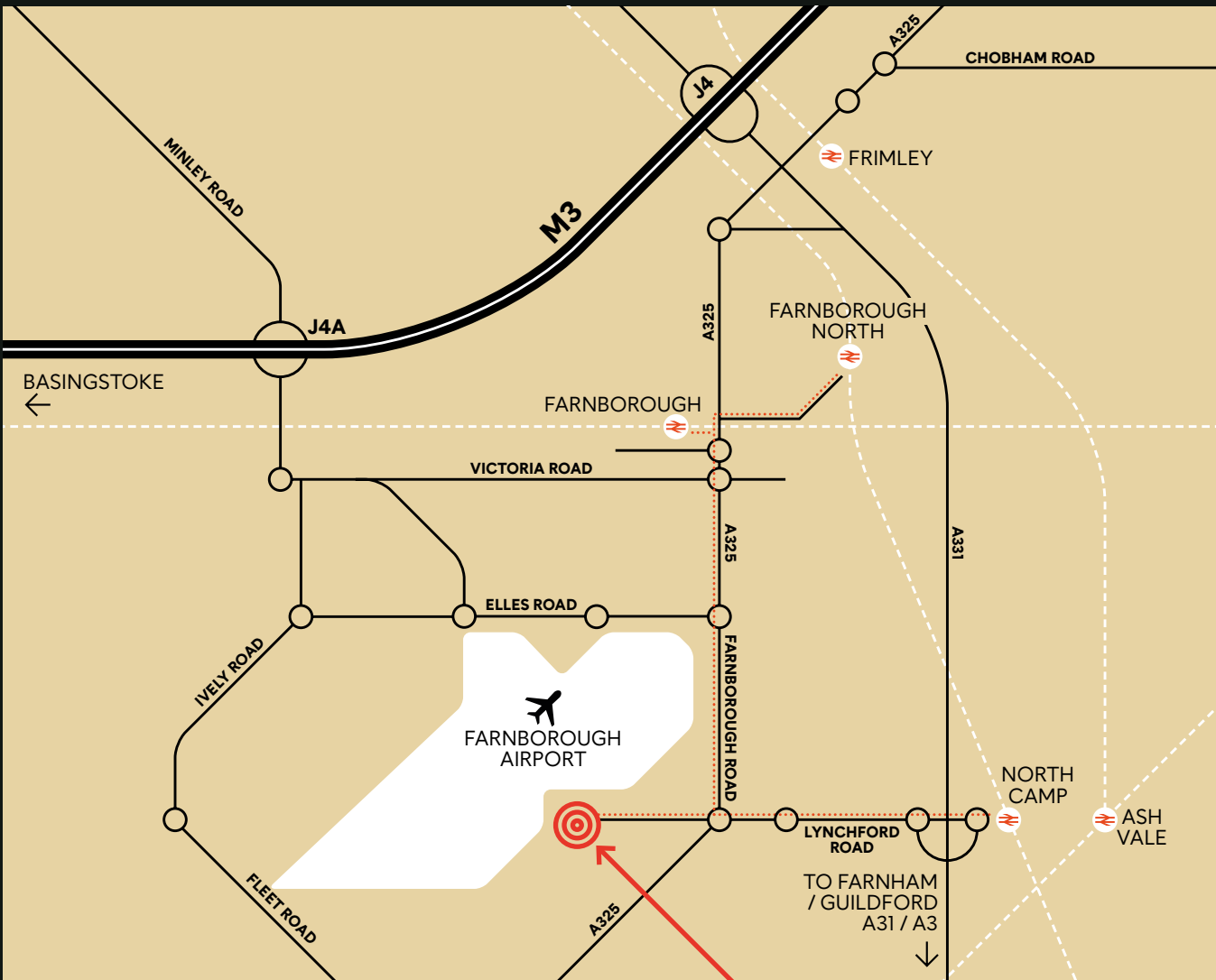


LOCATION

Chester House is situated on the successful Farnborough Aerospace Centre, one of the premier office parks in the Blackwater Valley, 2 miles south of the town centre in a landscaped environment covering 36 acres.

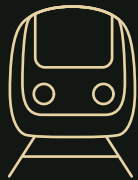
Farnborough is a globally recognised hub for research and development, defence and technology businesses and benefits from excellent road and rail connectivity being only 5 miles south of Junction 4 of the M3 motorway, 16 miles from the M25 motorway and 10 miles from the A3 dual carriageway.

Farnborough’s main railway station is approximately 2 miles to the north and provides direct services to London Waterloo, with a fastest journey time of 34 minutes.

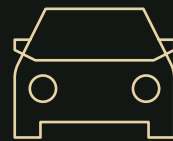
